Members of the Senate Judiciary Committee,

I am writing you today in firm opposition of SB 348! This Senate bill is almost a mirror image of Measure 114, which is being challenged in State and Federal court because of its unconstitutional nature.

Our US constitution recognized our God given right to keep and bear arms. These rights were included as the 2nd Amendment in our Bill of Rights by our founding fathers who knew that "We the People" would never be subjugated by a tyrannical government as long as we could defend ourselves with firearms.
