RE: Letter of Support for HB 3555

Dear members of the House Committee on Housing and Homelessness

We, the directors of Alianza Poder, write on behalf of the Alianza Poder Network to express our wholehearted support for HB 3555 which establishes Agricultural Housing New Construction and pre-development money to continuously appropriate money from funds to the Housing and Community Services Department for grants for new construction, acquisition and pre-development of agriculture workforce housing. Additionally, it requires the department to provide grants for urban community housing supporting agricultural employees. Alianza Poder knows first hand about the need for repair and maintenance as well as the need for new construction of housing for our farmworker community and HB3555 aligns with the work, goals, values and mission of our network.

Alianza Poder is a collaborative of sister organizations, which are serving, organizing, and building the leadership of our comunidades Latinas, Indigenas, y Afro-descendientes in Oregon to improve the quality of life for all, especially working families. Among the Alianza Poder (AP) organizations is Farmworker Housing Development Corporation (FHDC) which builds affordable housing for stable, more secure low-income working families and communities in Oregon. With the completion of the first of five complex buildings of Colonia Paz, FHDC has welcomed 24 new families to Colonia Paz in Lebanon. Phase II of Colonia Paz offers affordable workforce housing – from studios to three-bedroom units – to families who qualify. Each of the four buildings has 29 units, for a total of 116 – added to the 24 of phase I for a total of 130 affordable homes to the Lebanon community.

We serve families that are essential in our communities and want to continue being part of Oregon. They also feel relief in being able to afford their home as the cost of living continues to

increase. Familias Campesinas, and Farmworker communities deserve to live in dignified homes and together we can make sure Oregon is meeting the housing needs of our essential workers and neighbors.
