



How many projects have been proposed through county processes since HB 2329 (2019)? Did changing the jurisdictional thresholds in 2019 so that more projects go through the county process result in more renewable energy projects being built in Oregon?

HB 2329 was passed during the 2019 legislative session with the purpose of expediting renewable energy development. As part of the requirements of HB 2329, Counties must provide ODOE, among others, with notification of the application. ODOE has received notification for the following eight projects.
