RE: HB 5005 - Support for K-12 projects funded by OSCIM and SRGP

Co-Chair Girod, Co-Chair Holvey and members of the Subcommittee:

On behalf of the Coalition of Oregon School Administrators (COSA) and the Oregon School Boards Association (OSBA) we are asking for your support for \$161.2 million in Article XI-P bonds for the Oregon School Capital Improvement Matching Program (OSCIM) managed by the Oregon Department of Education and \$100.8 million of Article XI-M bonds for the Seismic Rehabilitation Grant Program (SRGP) managed by the Oregon Business Development Department. Both requests are included in the Governor's Recommended Budget.

We have submitted the list of OSCIM projects funded since the first round of grants in 2016 and the SRGP projects that were approved in May of 2021 and May of 2022 to give you a sense of the tremendous positive statewide impacts each of these programs have had for school districts in every corner of Oregon. In total, 299 school projects have been funded through the SGRP grants and close to 80 school districts have received OSCIM matching grants.

Currently, there is an additional \$55 million in SRGP funds to be awarded to eligible applicants in May of 2023. Please note that there are over \$180 million in applications for the remaining \$55 million, demonstrating the continued need to provide seismic upgrades throughout our K-12 and community college system. And there are 13 school districts awaiting the results of the May 2023 election cycle that are eligible to receive a bond matching grant through the OSCIM program if voters approve their bond request.

These investments are making much needed improvements in K-12 facilities across Oregon and have made an immeasurably positive impact across the state for students and local communities. But there is still a significant need for further investments.

We urge your support for investing \$100.8 million in the SRGP and \$161.2 million in the OSCIM bonding programs during the 2023-25 biennium. We want to be able to report back in two years another list of schools made seismically safe for students and communities that were able to pass a bond as a result of state matching funds. The investments in HB 5005 are critical to that effort.
