RE: SB 1089

To Senate Committee on Rules

Dear Chair Lieber, Vice Chair Knopp, and Members of the Committee:

My name is Tom Sincic. I am a retired Family Nurse Practitioner and serve as a volunteer in my role as President of Health Care for All Oregon.

As a Family Nurse Practitioner while I wanted to be caring for kids, I often found myself dealing with barriers to providing that care such as prior authorizations and out right denials by those that knew nothing of patient care or needs. This is just plain wrong.

The mission of Health Care for All Oregon is to “educate about and advocate for an equitable, affordable, comprehensive, high-quality publicly funded universal healthcare system that will improve the lives of individuals, families and communities.”

This mission aligns with the State’s intentions to have both affordable healthcare and achieve health equity. It is clear that the only way to do this is with true health care transformation. This is what passage of Senate Bill 1089 will do.

It is clear that the so called complexity often referred to as a “health care system” has failed in both areas. Just take a look at the Lara Media Report (attached or separately submitted) derived from extensive community listening sessions provided as part of the Joint Task Force on Universal Health Care Report delivered to the Legislature last September.
