Dear Ms. Dysinger,

Thank you again for your patience. The Jackson County Clerk has reviewed the remainder of your public records request received on December 28, 2022 and estimates that it will cost **\$982,896.17** to locate, review, and redact all requested documents. This estimate is calculated in accordance with ORS §192.324 and the Jackson County Fee Schedule, and is based on the Clerk's estimation of the amount staff time required to fulfill your request at the rate of \$163.88 per hour. In addition, you may be required to pay the County's standard rate for any copies, flash drives, or other devices that may be required for delivery of the documents.

Due to the enormous amount of staff time that would be required to fulfill your request, we estimate that it would take at least 1 year to provide all requested documents.

Please note this is only an estimate. If the actual cost of locating, reviewing, copying, and redacting the requested documents is higher than the estimate, you will be required to pay the difference before the documents will be provided to you. If the actual cost is lower, the County will refund the difference. In some cases, we may determine that additional redactions are necessary to protect voter identity. In such cases, the estimate will likely increase.

If you wish to pursue the above request, please notify me by email and I will provide you with an invoice for the estimated fees. At this time we estimate that it would take the Clerk up to 180 days from receipt of payment to fulfill your entire records request.

If a response is not received within 60 days of this email, then the County will consider your request closed.
