## Senate Bill 596

Sponsored by Senator TAYLOR (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.** 

Requires school districts to submit specified information to Department of Education related to talented and gifted children. Directs department to issue annual district and state report cards based on information.

(e) The percentage of talented and gifted children, as compared to the total population and to other talented and gifted children, who have regular attendance rates, as defined in **ORS 327.190, based on:** (A) Ethnicity. (B) Eligibility for English language learner programs. (C) Whether the student has an individualized education program or a plan developed in accordance with section 504 of the Rehabilitation Act of 1973, 29 U.S.C. 794. (D) Eligibility for free or reduced price lunches. (f) The percentage of talented and gifted children, as compared to the total population and to other talented and gifted children, who are in kindergarten through grade 8 and enrolled in accelerated college credit programs, as defined in ORS 340.300. (g) The percentage of talented and gifted children, as compared to the total population and to other talented and gifted children, who are in grades 9 through 12 and enrolled in: (A) Career and technical education courses. (B) Accelerated college credit programs, as defined in ORS 340.300. (C) Alternative education programs, as defined in ORS 336.615. (h) The number and difficulty level of high school mathematics and science courses taken by talented and gifted children, reported based on identification as talented and gifted children based on general intellectual ability, unusual academic ability in mathematics and unusual academic ability in language arts. (i) The percentage of talented and gifted children, as compared to the total population and to other talented and gifted children, who exceed standards in mathematics, language arts and science. (j) The percentage of students who exceed standards in mathematics, language arts and science who have been identified as talented and gifted children. (k) The number of full-time equivalent positions that are allocated to the instruction of

(1) The Superintendent of Public Instruction shall collect data and produce annual 10 school district and school performance reports to provide information to parents and to improve 11 12 schools. 13 (2) The superintendent shall include in the school district and school performance reports data for the following areas, for each school or district, that are available to the Department of Educa-14 15 tion from the most recent school year: 16 (a) Data required by the federal Every Student Succeeds Act (P.L. 114-95, 129 Stat. 1802); (b) Information about how to access the website that is maintained by the State Department of 17 Geology and Mineral Industries as provided by ORS 516.030 (6)(b); 18 (c) Information related to the number of children served in the district and the number of chil-19 20dren who are susceptible to restrictable disease, as reported under ORS 433.269 (2)(a); [and] (d) The information identified in section 2 of this 2023 Act; and 2122[(d)] (e) Any other data identified by the Department of Education as required by federal law to be in the reports. 23(3) In addition to the data required by subsection (2) of this section, the superintendent may 24 include other data on the school district and school performance reports. 25(4) The department shall work with stakeholders to: 2627(a) Design and implement an accountability system of progressive interventions for schools and school districts that do not demonstrate improvement; and 28(b) Provide technical assistance to schools and school districts that do not demonstrate im-2930 provement. 31 SECTION 4.
