Possible Work Session

HB 4004

Allows the Commissioner of the Bureau of Labor and Industries to impose civil penalties against a person for violating the child labor laws when the person has paid a civil penalty to the United States Department of Labor for a violation involving the same facts.

HB 4080 **

**Subsequent Referral(s) to Ways and Means

Declares a state policy to support engagement between offshore wind developers and impacted organizations, communities and tribes.

HB 4115

Modifies the definition of "supervisory employee" to exclude certain strike-prohibited public employees.

HB 4127

Creates rules and standards for warehouse employees' quota requirements.

Public Hearing

HB 4005

Clarifies when an employee is employed by employing unit or employer for a single hour of work for purposes of unemployment insurance and paid family and medical leave programs.

HB 4050

Provides factors upon which compensation differentials may be based for an employer to lawfully pay employees who perform work of comparable character at different compensation levels.
