HB 4014 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 2-14-2024 MEETING: Authorizes the State Department of Fish and Wildlife and the State Fish and Wildlife Commission to award moneys from the Oregon Conservation and Recreation Fund under a Landowners Living with Beavers Grant Program, on recommendations from the Oregon Conservation and Recreation Advisory Committee.

HB 4016 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 2-14-2024 MEETING: Makes certain changes to the Prescribed Fire Liability Pilot Program.

HB 4112 ** **Subsequent Referral(s) to Ways and Means
CARRIED OVER FROM THE 2-14-24 MEETING: Requires the Oregon Department of Administrative Services to adopt rules to govern procurements from clean energy technology companies.
