HB 4155 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Oregon Business Development Department to study infrastructure financing in Oregon by considering and evaluating tools the state may use to have a positive effect on infrastructure and housing costs in Oregon.

HB 4083  
Directs the Oregon Investment Council and the State Treasurer to make efforts to eliminate certain investments in thermal coal companies.

Directs the Department of Environmental Quality to study risks and issues relating to earthquake-induced toxic inhalation.

HB 4045 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Provides that district attorneys qualify as police officers under the Public Employees Retirement System.
