HB 4093

Requires at least one of the commissioners of the Oregon Liquor and Cannabis Commission to have a background in public health.

HB 4094

Authorizes the State Treasurer to issue Article XI-Q general obligation bonds to finance expansion of courthouses.

HB 4155 **

**Subsequent Referral(s) to Ways and Means

Directs the Oregon Business Development Department to study infrastructure financing in Oregon by considering and evaluating tools the state may use to have a positive effect on infrastructure and housing costs in Oregon.

HB 4083

CARRIED OVER FROM THE 02-13-2024 MEETING Directs the Oregon Investment Council and the State Treasurer to make efforts to eliminate certain investments in thermal coal companies.
