#### **Public Hearing**

SB 1517

Authorizes the urban flood safety and water quality district to annually assess benefited lands within the managed floodplain for the total amount of revenues required to pay the costs for the succeeding year of district works that directly benefit the lands.

  Prohibits the Department of Human Services from denying public assistance, including
  Supplemental Nutrition Assistance Program benefits, to COFA citizens based on their immigration status.

Establishes a semiquincentennial commission, to be known as the America 250 Oregon Commission, to coordinate and provide guidance for Oregon's official observance of the 250th anniversary of the establishment of the United States.
