1516 ** SB

**Subsequent Referral(s) to Ways and Means Establishes the Ireland Trade Commission.

1517 SB

Authorizes the urban flood safety and water quality district to annually assess benefited lands within the managed floodplain for the total amount of revenues required to pay the costs for the succeeding year of district works that directly benefit the lands.

SB 1548

For the part of the state located in the Pacific Time Zone, abolishes the annual one-hour change in time from standard time to daylight saving time and maintains the Pacific Time Zone portion of Oregon on standard time for all 12 months of the calendar year.

SB 1567 **

**Subsequent Referral(s) to Ways and Means Directs the Water Resources Department to take certain actions related to the Walla Walla Water 2050 Strategic Plan.

SB 1577 ** **Subsequent Referral(s) to Ways and Means

Extends automatic voter registration to applicants for admission to public institutions of higher education.
