**Subject:** DL OIS cert update

Good morning all,

Attached is information related to DL staff reported in IR's involving restraint alongside their OIS certification and background check information. This information is also represented in the shared document, but we found it easier to track separately as well. The chart at the top indicates potential concern for 8 staff members where restraints were performed prior to the current OIS certification and 2 staff certified at level G (general) who were involved in restraints. We will follow-up with DL on these current and former staff to learn whether they had a previous OIS certification at the time they were listed in IR's involving restraints and whether those certified at G are allowed to perform restraints.

Additionally, when cross examining these folks with the background check information, there appears to have been 23 staff involved in restraints prior to an approved background check. All 8 of the staff identified as potentially not being OIS certified did not have an approved background check for some of the IR's involving restraints as well. At least one of these 8 is a current staff member.

It should be noted that we have now verified, all staff working with youth are currently OIS certified.
