Subject:	SB 1530 – Relating to state financial administration Work Session Recommendations

SB 1530 appropriates General Fund to various agencies for housing-related purposes.

The measure declares an emergency and takes effect on passage.

#### **Recommended Changes**

The -A5 amendment appropriates \$279.6 million General Fund to various agencies for expenditure and disbursement to specific entities, summarized as follows:

The amendment increases Other Funds expenditure limitation for OHA, ODOE, and Water Resources Department by a total of \$20.5 million to enable the agencies to expend General Fund appropriated to specified accounts.

### **Budget Notes**

Budget Note: OBDD Infrastructure Reporting The Oregon Business Development Department is directed to report to the Joint Committee on Ways and Means in the 2025 legislative session on the status of infrastructure projects included in SB 1530 to support the development of housing. The report shall include the following information for each project:

- The project description, an updated estimate of total project cost, including total state and local support;
- Other sources of financing required to complete the project and whether they have been secured, noting state grant and loan programs accessed and associated amounts of funding;
- Status of contract execution, amount of state funding disbursed as of January 15, 2025, and estimated project completion date;

- An assessment of the likelihood for project completion by June 30, 2027, based on progress as of the date of the report; and
- The number of a) existing and b) additional/new housing units that will be served by the completed project.

LFO recommends adoption of the proposed budget note.
