STATE BOARD OF TAX PRACTITIONERS

The Governor has appointed the following individual to the State Board of Tax Practitioners subject to Senate confirmation.¹

Statement of Economic Interest²

Not required.

Composition³

The board consists of seven members, including:

- six licensed as tax consultants (BRADLEY, DRAKE-MINIOR, FEDELHOUSEN, THARP, WARTHEN, WEESNER); and
- one member of the general public (VACANT).

The tax consultants must have prepared personal income tax returns for at least five years. Members serve three-year terms and are eligible for appointment to no more than three terms in office.

Duties⁴

The board regulates tax consultants and tax preparers. The board must:

- determine licensure applicant qualifications; manage licensure examinations; and issue licenses for tax consultants and preparers;
- adopt and assess fees for specified services; and
- formulate a code of professional conduct.

The board may:

- refuse to issue or renew a license; suspend, revoke, or restore a license; or reprimand any licensee;
- enforce the laws administered by the board, investigate alleged violations, assess civil penalties of up to \$5,000 for specified violations, issue cease and desist orders, assess costs associated with disciplinary action against the licensee, and order restitution payments to anyone harmed by the violation;
- adopt necessary rules; and
- require completion of continuing educational programs.
