## OREGON BOARD OF DENTISTRY

---

The Governor has appointed the following individuals to the Oregon Board of Dentistry subject to Senate confirmation.<sup>1</sup>

### New Appointees

Ginny Jorgensen of Canby  
Olesya Salathe of Molalla  
Kristen Simmons of Hillsboro

### Terms

Jorgensen: April 7, 2024 – April 6, 2028  
Salathe: April 2, 2024 – April 1, 2028  
Simmons: April 1, 2024 – March 31, 2028

### Composition<sup>3</sup>

The board consists of 10 Oregon residents, including:<sup>4</sup>

- six active licensed dentists, with at least one practicing a specialty recognized by the American Dental Association (ALDRICH, CLARK, KALLURI, KANSAL, **SALATHE**, SHARIFI);
- two active licensed dental hygienists (LUDWIG, **SIMMONS**); and
- two public members who are not otherwise eligible for appointment, and who are not a spouse, domestic partner, child, parent or sibling of a dentist or dental hygienist (DUNN, **JORGENSEN**).

Members serve four-year terms and at the pleasure of the Governor. The active licensed dentists or dental hygienists may be selected from a list of nominees,

submitted by the Oregon Dental Association, the Oregon Dental Hygienists' Association, or any professional organization representing a dental specialty.

## **Duties<sup>5</sup>**

The board is authorized to:

- elect a president;
- make disbursements from the Oregon Board of Dentistry Account;
- employ staff for the investigation and enforcement of violations;
- conduct examinations for dentistry and dental hygiene license applicants;
- make and enforce rules necessary for the procedure of the board, for the conduct of examinations, for regulating the practice of dentistry, and for regulating the services of dental hygienists and dental auxiliary personnel;
- initiate and conduct investigations and hearings on all matters relating to the practice of dentistry, the discipline of licensees, or to the enforcement of provisions; and
- appoint a consultant or committee(s) to study and report to the board the condition of, and dental treatment rendered to, any person(s) by any licensed dentist(s) or by any person purporting to practice dentistry in Oregon.
