# Composition<sup>3</sup>

The board consists of nine Oregon residents, including:4

- five licensed pharmacists (BEAMAN, DEBARMORE, DOYLE, HALL, LINARES, PATEL);
- two licensed pharmacy technicians (DEPAULE, JOYCE); and
- two public members who are not licensed pharmacists or directly related to pharmacist (**CHINN**, HEMMINGS).

Members serve four-year terms. The pharmacists must be licensed and in good standing, engaged in the practice of pharmacy, and have five years of post-licensure experience. The pharmacy technicians must be licensed and in good standing, engaged

as a pharmacy technician, and have at least three years of post-licensure experience. Public members may not currently have, or have formerly had, any material financial interest in pharmacy services, and may not have engaged in any activity directly related to the practice of pharmacy.

The board elects its president and vice president and must meet at least once every three months.

#### **Duties**<sup>5</sup>

The board administers licensing for pharmacists, technicians, interns, and drug outlets and regulates the manufacture and distribution of drugs.

#### The board must:

- annually print and circulate copies of applicable changes in the laws and rules;
- appoint advisory committees;
- determine fees to be collected for specified services; and
- make, adopt, amend, and repeal such rules as may be deemed necessary.

#### The board may also:

- join professional organizations;
- require surety bonds to guarantee the performance and discharge of the duties of any officer or employee receiving and disbursing funds;
- receive and expend funds from parties other than the state;
- assign drug outlets uniform state numbers, in coordination with other states that have the same uniform numbering system;
- investigate, gather evidence concerning alleged violations, administer oaths, issue notices, issue and enforce subpoenas, and hold hearings;
- employ personnel; and
- require fingerprints.
