STATE BOARD OF DIRECT ENTRY MIDWIFERY

The Governor has appointed the following individuals to the State Board of Direct Entry Midwifery subject to Senate confirmation.¹

Not required.

Composition³

The board consists of seven Oregon residents, including:

- four licensed direct entry midwives (CLARK, KLEIN, PETTIBONE, MANCE);
- one certified nurse midwife (MORALES);
- one licensed physician involved, at the time of appointment, in obstetrical care or education (RONICK); and
- one member of the public (EIVA).

Members serve three-year terms. Licensed direct entry midwives may be from a list of nominees, submitted by related professional organizations. The board elects its chair.⁴

Duties⁵

The board must adopt rules for the administration of direct entry midwifery licensing, practice, and discipline.
