Terms

ORS 455.140 and 455.144 (2023).

Statement of Economic Interest²

Composition³

The board consists of ten members, including:4

- a plumbing industry representative (SCHEUERMANN);
- a sheet metal and air conditioner contractor (MILLER);
- a municipal mechanical inspector possessing the highest certification issued by the Department of Consumer and Business Services (FERGUSON);
- a heating, venting, and air conditioning contractor (HANSEN);
- a heating, venting, and air conditioning installer (FANNING);
- a sheet metal and air conditioner installer (FRAZIER);
- a natural gas company (or other utility) representative (DUELL);
- a building official (ZUK);
- a craftsperson with experience with heat and frost insulation (CAUDLE); and
- a member of the public who is not compensated by any interest represented on the board (LOUIE).

Members serve four-year terms and are limited to two full terms. They may be removed for good cause, including three unexcused absences during any 12-month period. A majority of appointees constitutes a quorum and they must meet at least twice a year in consultation with the Department of Consumer and Business Services (DCBS).

Duties⁵

The board assists the Director of DCBS with administration of the installation code for mechanical devices and equipment. Its duties include:

- consulting with DCBS on the adoption of uniform energy conservation standards and the Reach Code:
- advising DCBS on standards, qualifications, and training for building officials and inspectors;
- making certain findings, prior to DCBS rulemaking, concerning the Mechanical Specialty Code (Code);
- reviewing the Code and making recommendations; approving rules and Code changes; approving technical and scientific facts related to proposed materials, designs, or methods of construction; approving alternative regulatory options for emerging technologies;
- adjudicating appeals of Code violations, building official decisions, and municipal appeals board decisions, and imposing sanctions;
- consulting with DCBS regarding alternative permit and inspection programs, including a statewide permitting and inspection program for minor construction work; and
- selecting two members to serve on the Construction Industry Energy Board.
