Bill Title: Relating to state financial administration; declaring an emergency.

Government Unit(s) Affected: Oregon Health Authority, Oregon Business Development Department, Housing and Community Services Department, Department of Administrative Services, Department of Public Safety Standards and Training

Summary of Fiscal Impact

This bill clarifies the application of statutes to support the 2023-25 legislatively adopted budget- see explanatory analysis.

Measure Description

This measure implements statutory changes necessary to support the 2023-25 legislatively adopted budget and to clarify the application of statutes. This measure, relating to state financial administration, is not an appropriation bill and therefore does not include the appropriation of funds.
