SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to laws about prescription drugs and some health care providers. The Act says the Oregon State Hospital does not have to do certain things about staffing. The Act changes the term "physician assistant" to "physician associate." (Flesch Readability Score: 62.1).

[Digest: This Act makes changes to laws about prescription drugs, health insurance and some health care providers. The Act says the Oregon State Hospital does not have to do certain things about staffing. The Act changes the term "physician assistant" to "physician associate." (Flesch Readability Score: 60.4).]

Specifies that flavoring of a prescription drug is not compounding. *[Prohibits drug manufacturers from restricting access to certain prescription drugs.]* Exempts the Oregon State Hospital from certain hospital staffing requirements. *[Removes the requirement that optometrists have hospital consulting privileges in order to qualify for tax credit.]* Removes requirement that an applicant for licensure as a licensed professional counselor or therapist submit a professional disclosure statement. Changes the term "physician assistant" to "physician associate." *[Requires health insurers to negotiate with health care interpreters and certain health care providers regarding coverage of health care interpretation services.]*

Takes effect on the 91st day following adjournment sine die.

3 **DRUGS**

4
5 **SECTION 1. Section 2 of this 2024 Act is added to and made a part of ORS chapter 689.**

6 **SECTION 2. The addition of flavoring to a drug intended for dispensation may not be**
7 **considered compounding if the flavoring:**

8 (1) **Is inert, nonallergenic and has no effect other than imparting a flavor to the drug or**
9 **modifying the flavor of the drug; and**

10 (2) **Does not constitute more than five percent of the total volume of the drug.**

11 **NOTE:** Section 3 was deleted by amendment. Subsequent sections were not renumbered.

13 **HOSPITAL STAFFING**

14
15 **SECTION 4.** ORS 441.775 is amended to read:

16 441.775. (1)(a) For each hospital there shall be established a hospital professional and technical
17 staffing committee. A hospital professional and technical staffing committee shall consist of an equal
18 number of hospital professional and technical managers and professional and technical staff who
19 work at the hospital.

20 (b) If the professional and technical staff who work at the hospital have an exclusive represen-
21 tative, the exclusive representative shall select the staff members of the hospital professional and
22 technical staffing committee.

23 (c) If none of the professional and technical staff who work at the hospital have an exclusive
24 representative, the professional and technical managers shall select the professional and technical
25 staff members of the hospital professional and technical staffing committee.

26 (2) A hospital professional and technical staffing committee shall develop a written hospital-wide
27 professional and technical staffing plan in accordance with subsection (5) of this section. In devel-
28 oping the staffing plan, the primary goal of the committee shall be to ensure that the hospital is
29 staffed sufficiently to meet the health care needs of the patients in the hospital. The committee shall
30 review and modify the staffing plan, as needed, in accordance with this section.

31 (3) A majority of the members of the hospital professional and technical staffing committee
32 constitutes a quorum for the transaction of business.

33 (4) A hospital professional and technical staffing committee must have two cochair. One cochair
34 shall be a professional or technical manager elected by the members of the committee who are
35 professional or technical managers. The other cochair shall be a professional or technical staff
36 person elected by the members of the committee who are professional and technical staff.

37 (5)(a) A hospital professional and technical staffing committee shall develop a professional and
38 technical staffing plan that is consistent with the approved nurse staffing plan for the hospital and
39 that takes into account the hospital service staffing plan for the hospital developed under ORS
40 441.776.

41 (b) The hospital professional and technical staffing committee shall consider the following cri-
42 teria when developing the professional and technical staffing plan:

43 (A) The hospital's census;

44 (B) Location of the patients;

45 (C) Patient types and patient acuity;

- 1 (D) National standards, if any;
- 2 (E) The size of the hospital and square footage of the hospital;
- 3 (F) Ensuring patient access to care; and
- 4 (G) Feedback received during committee meetings from staff.

5 (6)(a) A hospital professional and technical staffing committee must adopt a professional and
6 technical staffing plan by a majority vote of the members of the committee. If a quorum of members
7 present at a meeting comprises an unequal number of professional and technical staff and profes-
8 sional and technical managers, only an equal number of staff and managers may vote. A staffing plan
9 adopted by the committee must include a summary of the committee's consideration of the criteria
10 in subsection (5) of this section and how the plan:

11 (A) Is consistent with the approved nurse staffing plan for the hospital; and

12 (B) Takes into account the hospital service staffing plan for the hospital that was developed in
13 accordance with ORS 441.776.

14 (b) If the hospital professional and technical staffing committee does not adopt a professional
15 and technical staffing plan or adopts only a part of the staffing plan, either cochair may invoke the
16 commencement of a 60-day period during which the committee shall continue to develop the staffing
17 plan. If, by the end of the 60-day period, the committee does not adopt a staffing plan or adopts only
18 part of a staffing plan, the committee shall submit the disputed plan or parts of the plan, as appli-
19 cable, including a summary of the committee's consideration of the criteria in subsection (5) of this
20 section, to the chief executive officer of the hospital. No later than 60 days after receiving the
21 submission from the committee, the chief executive officer or the chief executive officer's designee
22 shall decide the disputed plan or parts of the plan, as applicable, considering the summary of the
23 committee's consideration of the criteria in subsection (5) of this section, and adopt the staffing plan
24 or parts of the staffing plan that were not adopted by the committee. The chief executive officer or
25 the chief executive officer's designee shall provide to the committee:

26 (A) A written explanation of the staffing plan or the parts of the staffing plan that were in dis-
27 pute;

28 (B) The final written proposals of the members of the committee and the members' rationales for
29 their proposals and the committee's summary of the committee's consideration of the criteria in
30 subsection (5) of this section; and

31 (C) A summary of the consideration by the chief executive officer or the chief executive officer's
32 designee of the criteria in subsection (5) of this section.

33 (c) If the hospital professional and technical staffing committee is unable to reach an agreement
34 on the professional and technical staffing plan during the 60-day period invoked under paragraph (b)
35 of this subsection, the members of the committee may extend deliberations for one additional 60-day
36 period before the disputed plan or parts of the plan must be submitted to the chief executive officer
37 or the chief executive officer's designee in accordance with paragraph (b) of this subsection. The
38 deliberations may be extended under this paragraph only by a majority vote of the members of the
39 committee. If a quorum of members present at a meeting comprises an unequal number of profes-
40 sional and technical staff and professional and technical managers, only an equal number of staff
41 and managers may vote.

42 (d) A professional and technical staffing plan adopted by a hospital professional and technical
43 staffing committee, a chief executive officer or the chief executive officer's designee must include
44 any staffing-related terms and conditions that were previously adopted through any applicable col-
45 lective bargaining agreement, including any meal break and rest break requirements, unless a term

1 or condition is in direct conflict with an applicable statute or administrative rule.

2 (7) A hospital professional and technical staffing committee must meet three times each year and
3 at the call of either cochair, at a time and place specified by the cochairs.

4 (8)(a) Except as provided in paragraph (b) of this subsection, a hospital professional and tech-
5 nical staffing committee meeting must be open to:

6 (A) The hospital's professional and technical staff, who shall be offered the opportunity to pro-
7 vide feedback to the committee during the committee's meetings; and

8 (B) Other observers or presenters invited by either cochair.

9 (b) While the committee is deliberating or voting during a meeting, either cochair may exclude
10 individuals described in paragraph (a) of this subsection.

11 (9) Minutes must be taken at every hospital professional and technical staffing committee
12 meeting and the minutes must:

13 (a) Include all motions made and the outcome of all votes taken;

14 (b) Include a summary of all discussions; and

15 (c) Be made available in a timely manner to any of the hospital staff upon request.

16 (10) A manager shall release from their duties staff and managers who serve on the hospital
17 professional and technical staffing committee and compensate the staff and managers who serve on
18 the committee for time spent attending committee meetings.

19 (11) The hospital shall submit the professional and technical staffing plan adopted under sub-
20 section (6) of this section to the Oregon Health Authority no later than 30 days after adoption of
21 the staffing plan and shall submit any subsequent changes to the authority no later than 30 days
22 after the changes are adopted.

23 (12) Each hospital unit, as defined by the chief executive officer or the chief executive officer's
24 designee, may deviate from the professional and technical staffing plan within a period of 12 con-
25 secutive hours, no more than six times during a rolling 30-day period, without being in violation of
26 the staffing plan. The unit manager must notify the hospital professional and technical staffing
27 committee cochairs no later than 10 days after each deviation. Each subsequent deviation during the
28 30-day period constitutes a separate violation under ORS 441.792.

29 **(13) This section does not apply to the Oregon State Hospital.**

30 **SECTION 5.** ORS 441.776 is amended to read:

31 441.776. (1)(a) For each hospital there shall be established a hospital service staffing committee.
32 A hospital service staffing committee shall consist of an equal number of service staff managers and
33 service staff who work at the hospital.

34 (b) If the service staff who work at the hospital have an exclusive representative, the exclusive
35 representative shall select the service staff members of the hospital service staffing committee.

36 (c) If none of the service staff who work at the hospital have an exclusive representative, the
37 service staff managers shall select the service staff members of the hospital service staffing com-
38 mittee.

39 (2) A hospital service staffing committee shall develop a written hospital-wide hospital service
40 staffing plan in accordance with subsection (5) of this section. The committee shall review and
41 modify the staffing plan as needed in accordance with this section.

42 (3) A majority of the members of the hospital service staffing committee constitutes a quorum
43 for the transaction of business.

44 (4) A hospital service staffing committee must have two cochairs. One cochair shall be a service
45 staff manager elected by the members of the committee who are service staff managers. The other

1 cochair shall be a service staff person elected by the members of the committee who are service
2 staff.

3 (5) A hospital service staffing committee shall develop a hospital service staffing plan that is
4 consistent with the approved nurse staffing plan for the hospital and that takes into account the
5 professional and technical staffing plan for the hospital developed under ORS 441.775. The committee
6 shall consider the following criteria in developing the staffing plan:

- 8 (b) Location of the patients;
- 9 (c) Patient types and patient acuity;
- 10 (d) National standards, if any;
- 11 (e) The size of the hospital and square footage of the hospital;
- 12 (f) Ensuring patient access to care; and
- 13 (g) Feedback received during committee meetings from staff.

14 (6)(a) A hospital service staffing committee must adopt a hospital service staffing plan by a
15 majority vote of the members of the committee. If a quorum of members present at a meeting com-
16 prises an unequal number of service staff and service staff managers, only an equal number of staff
17 and managers may vote. A staffing plan adopted by the committee must include a summary of the
18 committee's consideration of the criteria in subsection (5) of this section and how the plan:

- 19 (A) Is consistent with the approved nurse staffing plan for the hospital; and
- 20 (B) Takes into account the professional and technical staffing plan for the hospital that was
21 developed in accordance with ORS 441.775.

22 (b) If the hospital service staffing committee does not adopt a hospital service staffing plan or
23 adopts only a part of the staffing plan, either cochair may invoke the commencement of a 60-day
24 period during which the committee shall continue to develop the staffing plan. If, by the end of the
25 60-day period, the committee does not adopt a staffing plan or adopts only part of a staffing plan,
26 the committee shall submit the disputed plan or parts of the plan, as applicable, including a summary
27 of the committee's consideration of the criteria in subsection (5) of this section, to the chief execu-
28 tive officer of the hospital. No later than 60 days after receiving the submission from the committee,
29 the chief executive officer or the chief executive officer's designee shall decide the disputed plan
30 or parts of the plan, as applicable, considering the summary of the committee's consideration of the
31 criteria in subsection (5) of this section, and adopt the staffing plan or parts of the staffing plan that
32 were not adopted by the committee. The chief executive officer or the chief executive officer's
33 designee shall provide to the committee:

- 34 (A) A written explanation of the staffing plan or the parts of the staffing plan that were in dis-
35 pute;
- 36 (B) The final written proposals of the members of the committee and the members' rationales for
37 their proposals and the committee's summary of the committee's consideration of the criteria in
38 subsection (5) of this section; and
- 39 (C) A summary of the consideration by the chief executive officer or the chief executive officer's
40 designee of the criteria in subsection (5) of this section.

41 (c) If the hospital service staffing committee is unable to reach an agreement on the hospital
42 service staffing plan during the 60-day period invoked under paragraph (b) of this subsection, the
43 members of the committee may extend deliberations for one additional 60-day period before the dis-
44 puted plan or parts of the plan must be submitted to the chief executive officer or the chief execu-
45 tive officer's designee in accordance with paragraph (b) of this subsection. The deliberations may

1 be extended under this paragraph only by a majority vote of the members of the committee. If a
2 quorum of members present at a meeting comprises an unequal number of hospital service staff and
3 hospital service managers, only an equal number of staff and managers may vote.

4 (d) A hospital service staffing plan adopted by a hospital service staffing committee, a chief
5 executive officer or the chief executive officer's designee must include any staffing-related terms and
6 conditions that were previously adopted through any applicable collective bargaining agreement,
7 including any meal break and rest break requirements, unless a term or condition is in direct con-
8 flict with an applicable statute or administrative rule.

9 (7) A hospital service staffing committee must meet three times each year and at the call of ei-
10 ther cochair, at a time and place specified by the cochairs.

11 (8)(a) Except as provided in paragraph (b) of this subsection, a hospital service staffing com-
12 mittee meeting must be open to:

13 (A) The hospital's service staff, who shall be offered the opportunity to provide feedback to the
14 committee during the committee's meetings; and

15 (B) Other observers or presenters invited by either cochair.

16 (b) While the committee is deliberating or voting during a meeting, either cochair may exclude
17 individuals described in paragraph (a) of this subsection.

18 (9) Minutes must be taken at every hospital service staffing committee meeting and the minutes
19 must:

20 (a) Include all motions made and the outcome of all votes taken;

21 (b) Include a summary of all discussions; and

22 (c) Be made available in a timely manner to any of the hospital staff upon request.

23 (10) A manager shall release from their duties staff and managers who serve on the hospital
24 service staffing committee and compensate the staff and managers who serve on the committee for
25 time spent attending committee meetings.

26 (11) The hospital shall submit the hospital service staffing plan adopted under subsection (6) of
27 this section to the Oregon Health Authority no later than 30 days after adoption of the staffing plan
28 and shall submit any subsequent changes to the authority no later than 30 days after the changes
29 are adopted.

30 (12) Each hospital unit, as defined by the chief executive officer or the chief executive officer's
31 designee, may deviate from the hospital service staffing plan within a period of 12 consecutive hours,
32 no more than six times during a rolling 30-day period, without being in violation of the staffing plan.
33 The unit manager must notify the hospital service staffing committee cochairs no later than 10 days
34 after each deviation. Each subsequent deviation during the 30-day period constitutes a separate vi-
35 olation under ORS 441.792.

36 **(13) This section does not apply to the Oregon State Hospital.**

41 **SECTION 8.** ORS 743B.221 is amended to read:

42 743B.221. (1) As used in this section, "primary care provider" means an individual, **clinic or**
43 **team of health care providers** licensed or certified in this state to provide outpatient, nonspecialty
44 medical services or the coordination of health care for the purpose of:

45 (a) Promoting or maintaining mental and physical health and wellness; and

1 (b) Diagnosis, treatment or management of acute or chronic conditions caused by disease, injury
2 or illness.

3 (2) An insurer offering an individual or group policy or certificate of health insurance that re-
4 imbursees the cost of hospital, medical or surgical expenses, other than coverage limited to expenses
5 from accidents or specific diseases and limited benefit coverage, must assign a beneficiary under the
6 policy or certificate to a primary care provider if the beneficiary or a parent of a minor beneficiary
7 has not selected a primary care provider by the 90th day of the plan year. If the insurer assigns the
8 beneficiary to a primary care provider, the insurer shall provide notice of the assignment to the
9 beneficiary or parent and to the primary care provider.

10 (3) A beneficiary may select a different primary care provider at any time.

11 (4) The Department of Consumer and Business Services shall adopt rules prescribing a method-
12 ology for assignment and attribution of beneficiaries, to ensure accuracy and agreement between
13 insurers and providers. The rules must prioritize consumer choice, ensure collaboration between
14 insurers and providers and be consistent with recommendations of the primary care payment reform
15 collaborative described in section 2, chapter 575, Oregon Laws 2015.

16 **SECTION 9.** ORS 743B.221, as amended by section 14, chapter 37, Oregon Laws 2022, is
17 amended to read:

18 743B.221. (1) As used in this section, “primary care provider” means an individual, **clinic or**
19 **team of health care providers** licensed or certified in this state to provide outpatient, nonspecialty
20 medical services or the coordination of health care for the purpose of:

22 (b) Diagnosis, treatment or management of acute or chronic conditions caused by disease, injury

39 **SECTION 10.** ORS 675.755 is amended to read:

40 675.755. (1) Except as provided in subsection [(6)] (4) of this section, prior to the performance
41 of professional counseling or marriage and family therapy, [*the*] **a** licensee must furnish the client
42 with a copy of a professional disclosure statement. If the licensee fails to provide the statement, the
43 licensee [*shall*] **may** not charge [*a*] **the** client a fee for services.

44 (2) A professional disclosure statement [*shall*] **must** include the following information regarding
45 the [*applicant or*] licensee:

- 1 (a) Name, business address and telephone number;
- 2 (b) Philosophy and approach to counseling or marriage and family therapy;
- 3 (c) Formal education and training;
- 4 (d) Continuing education and supervision requirements; and
- 5 (e) Fee schedules.

6 (3) The statement must include the name, address and telephone number of the Oregon Board
7 of Licensed Professional Counselors and Therapists.

8 [(4) An applicant shall submit a professional disclosure statement for board approval upon appli-
9 cation for a license.]

10 [(5) Whenever an applicant or licensee makes a change in the professional disclosure statement, the
11 new statement shall be presented to the board for approval.]

12 [(6)] (4) The board may adopt by rule exemptions from the requirements of this section.

13 **SECTION 11. The amendments to ORS 675.755 by section 10 of this 2024 Act apply to ap-
14 plications received by the Oregon Board of Licensed Professional Counselors and Marriage
15 and Family Therapists on or after the effective date of this 2024 Act and to professional
16 disclosure statements changed on or after the effective date of this 2024 Act.**

11 3.450. (1) As used in this section:

12 (a) "Drug court program" means a program in which:

13 (A) Individuals who are before the court obtain treatment for substance abuse issues and report
14 regularly to the court on the progress of their treatment; and

15 (B) A local drug court team, consisting of the court, agency personnel and treatment and service
16 providers, monitors the individuals' participation in treatment.

17 (b) "Individual-provider relationship" includes a relationship between an individual and a phy-
18 sician, a [*physician assistant*] **physician associate** or nurse practitioner.

19 (2)(a) The governing body of a county or a treatment provider may establish fees that individuals

- 19 (6) Research conducted in accordance with this section is rebuttably presumed to comply with
- 20 ORS 192.535 and 192.539.
- 21 (7)(a) Notwithstanding ORS 192.535, a person may use a DNA sample or genetic information
- 22 obtained, with blanket informed consent, before June 25, 2001, for genetic research.

9 county or municipality operating a clinical laboratory or the owner of any institution operating a

12 (17) "Physician performed microscopy procedure" means a test personally performed by a phy-

17 (19) "Specimen" means materials derived from a human being or body.

18 (20) "Substances of abuse" means ethanol, cannabis and controlled substances.

19 (21) "Substances of abuse on-site screening facility" or "on-site facility" means a location where
20 on-site tests are performed on specimens for the purpose of screening for the detection of substances
21 of abuse.

22 (22) "Substances of abuse on-site screening test" or "on-site test" means a substances of abuse
23 test that is easily portable and can meet the requirements of the federal Food and Drug Adminis-
24 tration for commercial distribution or an alcohol screening test that meets the requirements of the
25 conforming products list found in the United States Department of Transportation National Highway
26 Traffic Safety Administration Docket No. 94-004 and meets the standards of the United States De-

29 (23) "Waived test" means a procedure performed on materials derived from the human body that
30 meet the criteria for this category of testing as established by the authority.

44 (7) "Manager" means a person licensed by the superintendent who does any of the following:

45 (a) By contract or agreement undertakes to represent the interests of a professional unarmed

1 combat sports competitor in procuring or arranging the conduct of an unarmed combat sports event
2 in which the professional unarmed combat sports competitor is a participant.

3 (b) Receives or is entitled to receive more than 10 percent of the contracted portion of the gross
4 purse of a professional unarmed combat sports competitor for services related to the unarmed com-
5 bat sports competitor's participation in an unarmed combat sports event.

6 (c) Is an officer, director or stockholder of a corporation that receives or is entitled to receive

10 (d) Directs or controls the professional activities of a professional unarmed combat sports com-

18 (9) "Medical personnel" means a physician licensed under ORS chapter 677 or a [*physician as-*

38 submission grappling or other martial art where the intent is for the competitor to win by points
39 only and where that martial art is exhibited independently.

40 (17) "Unarmed combat sports competitor" means an individual licensed by the superintendent

11 (5) "Board" means the State Board of Pharmacy.

12 (6) "Controlled substance":

13 (a) Means a drug or its immediate precursor classified in Schedules I through V under the fed-
14 eral Controlled Substances Act, 21 U.S.C. 811 to 812, as modified under ORS 475.035. The use of the
15 term "precursor" in this paragraph does not control and is not controlled by the use of the term
16 "precursor" in ORS 475.752 to 475.980.

17 (b) Does not include:

18 (A) The plant Cannabis family Cannabaceae;

19 (B) Any part of the plant Cannabis family Cannabaceae, whether growing or not;

20 (C) Resin extracted from any part of the plant Cannabis family Cannabaceae;

21 (D) The seeds of the plant Cannabis family Cannabaceae;

22 (E) Any compound, manufacture, salt, derivative, mixture or preparation of a plant, part of a
23 plant, resin or seed described in this paragraph; or

31 (8) "Deliver" or "delivery" means the actual, constructive or attempted transfer, other than by
32 administering or dispensing, from one person to another of a controlled substance, whether or not

34 (9) "Device" means instruments, apparatus or contrivances, including their components, parts
35 or accessories, intended:

11 received through technological apparatuses, including computer terminals or other equipment or
12 mechanisms linked by telephone or microwave relays, or any similar apparatus having electrical,

14 (15) “Manufacture” means the production, preparation, propagation, compounding, conversion

34 affixed to a drug prepared under written, oral or electronically transmitted direction shall promi-
35 nently display a warning that the removal thereof is prohibited by law.

38 (20) “Research” means an activity conducted by the person registered with the federal Drug

28 [*physician assistant*] **physician associate** or nurse practitioner and that the physician, naturopathic
29 physician, [*physician assistant*] **physician associate** or nurse practitioner furnish the department
30 with a certificate stating whether the person is affected with any infectious or contagious disease.
31 If within five days after so required the person has not furnished the department with such a cer-
32 tificate by a competent physician, naturopathic physician, [*physician assistant*] **physician associate**
33 or nurse practitioner, the person is guilty of a violation of ORS 616.745 and the department may
34 apply to the circuit court to enjoin the person from continuing to work in the food establishment
35 until the certificate is furnished. The circuit court hereby is authorized to issue the injunction.

36 **SECTION 109.** ORS 628.270 is amended to read:

37 628.270. (1) The Oregon Health Authority may, by rule, define certain communicable diseases
38 which may be spread to the public through the handling of food in refrigerated locker plants.

39 (2) A person who has a communicable or infectious disease described in subsection (1) of this
40 section may not be permitted to work in or about any refrigerated locker plant or to handle any food
41 in connection with the operation of such plant.

42 (3) In the discretion of the State Department of Agriculture, an employee of a locker plant may
43 be required to furnish a certificate of health from a physician, naturopathic physician, [*physician*
44 *assistant*] **physician associate** or nurse practitioner duly accredited by the authority for the purpose
45 of issuing such certificates. If such certificate is required under municipal ordinance upon exam-

1 ination deemed adequate by the authority, a certificate issued in compliance with such ordinance is
2 sufficient under this section.

3 (4) Any health certificate required by this section shall be revoked by the authority at any time
4 that the holder thereof is found, upon physical examination of such holder, to have any
5 communicable or infectious disease. Refusal of any person employed in such locker plant to submit
6 to proper and reasonable physical examination, upon written demand by the authority or the de-
7 partment, is cause for revocation of the employee's health certificate and also is sufficient reason
8 for revocation of the locker plant's license unless the employee immediately is removed from any
9 work or operation in or about such locker plant involving the handling of food.

10 **SECTION 110.** ORS 656.005 is amended to read:

11 656.005. (1) "Average weekly wage" means the Oregon average weekly wage in covered em-
12 ployment, as determined by the Employment Department, for the last quarter of the calendar year
13 preceding the fiscal year in which the injury occurred.

14 (2)(a) "Beneficiary" means an injured worker, and the spouse in a marriage, child or dependent
15 of a worker, who is entitled to receive payments under this chapter.

16 (b) "Beneficiary" does not include a person who intentionally causes the compensable injury to
17 or death of an injured worker.

18 (3) "Board" means the Workers' Compensation Board.

19 (4) "Carrier-insured employer" means an employer who provides workers' compensation cover-
20 age with the State Accident Insurance Fund Corporation or an insurer authorized under ORS
21 chapter 731 to transact workers' compensation insurance in this state.

22 (5) "Child" means a child of an injured worker, including:

23 (a) A posthumous child;

24 (b) A child legally adopted before the injury;

25 (c) A child toward whom the worker stands in loco parentis;

26 (d) A child born out of wedlock;

27 (e) A stepchild, if the stepchild was, at the time of the injury, a member of the worker's family
28 and substantially dependent upon the worker for support; and

29 (f) A child of any age who was incapacitated at the time of the accident and thereafter remains
30 incapacitated and substantially dependent on the worker for support.

31 (6) "Claim" means a written request for compensation from a subject worker or someone on the
32 worker's behalf, or any compensable injury of which a subject employer has notice or knowledge.

33 (7)(a) A "compensable injury" is an accidental injury, or accidental injury to prosthetic appli-
34 ances, arising out of and in the course of employment requiring medical services or resulting in
35 disability or death. An injury is accidental if the result is an accident, whether or not due to acci-
36 dental means, if it is established by medical evidence supported by objective findings, subject to the
37 following limitations:

38 (A) An injury or disease is not compensable as a consequence of a compensable injury unless
39 the compensable injury is the major contributing cause of the consequential condition.

40 (B) If an otherwise compensable injury combines at any time with a preexisting condition to
41 cause or prolong disability or a need for treatment, the combined condition is compensable only if,
42 so long as and to the extent that the otherwise compensable injury is the major contributing cause
43 of the disability of the combined condition or the major contributing cause of the need for treatment
44 of the combined condition.

45 (b) "Compensable injury" does not include:

1 (A) Injury to any active participant in assaults or combats that are not connected to the job
2 assignment and that amount to a deviation from customary duties;

3 (B) Injury incurred while engaging in or performing, or as the result of engaging in or per-
4 forming, any recreational or social activities primarily for the worker's personal pleasure; or

5 (C) Injury the major contributing cause of which is demonstrated to be by a preponderance of
6 the evidence the injured worker's consumption of alcoholic beverages or cannabis or the unlawful
7 consumption of any controlled substance, unless the employer permitted, encouraged or had actual
8 knowledge of such consumption.

9 (c) A "disabling compensable injury" is an injury that entitles the worker to compensation for
10 disability or death. An injury is not disabling if no temporary benefits are due and payable, unless
11 there is a reasonable expectation that permanent disability will result from the injury.

12 (d) A "nondisabling compensable injury" is any injury that requires medical services only.

13 (8) "Compensation" includes all benefits, including medical services, provided for a compensable
14 injury to a subject worker or the worker's beneficiaries by an insurer or self-insured employer pur-
15 suant to this chapter.

16 (9) "Department" means the Department of Consumer and Business Services.

17 (10) "Dependent" means any of the following individuals who, at the time of an accident, de-
18 pended in whole or in part for the individual's support on the earnings of a worker who dies as a
19 result of an injury:

20 (a) A parent of a worker or the parent's spouse or domestic partner;

21 (b) A grandparent of a worker or the grandparent's spouse or domestic partner;

22 (c) A grandchild of a worker or the grandchild's spouse or domestic partner;

23 (d) A sibling or stepsibling of a worker or the sibling's or stepsibling's spouse or domestic
24 partner; and

25 (e) Any individual related by blood or affinity whose close association with a worker is the
26 equivalent of a family relationship.

27 (11) "Director" means the Director of the Department of Consumer and Business Services.

28 (12)(a) "Doctor" or "physician" means a person duly licensed to practice one or more of the
29 healing arts in any country or in any state, territory or possession of the United States within the
30 limits of the license of the licensee.

31 (b) Except as otherwise provided for workers subject to a managed care contract, "attending
32 physician" means a doctor, physician or [*physician assistant*] **physician associate** who is primarily
33 responsible for the treatment of a worker's compensable injury and who is:

34 (A) A physician licensed under ORS 677.100 to 677.228 by the Oregon Medical Board, or a
35 podiatric physician and surgeon licensed under ORS 677.805 to 677.840 by the Oregon Medical
36 Board, an oral and maxillofacial surgeon licensed by the Oregon Board of Dentistry or a similarly
37 licensed doctor in any country or in any state, territory or possession of the United States;

38 (B) For a cumulative total of 60 days from the first visit on the initial claim or for a cumulative
39 total of 18 visits, whichever occurs first, to any of the medical service providers listed in this sub-
40 paragraph, a:

41 (i) Doctor or physician licensed by the State Board of Chiropractic Examiners for the State of
42 Oregon under ORS chapter 684 or a similarly licensed doctor or physician in any country or in any
43 state, territory or possession of the United States; or

44 (ii) Doctor of naturopathy or naturopathic physician licensed by the Oregon Board of
45 Naturopathic Medicine under ORS chapter 685 or a similarly licensed doctor or physician in any

1 country or in any state, territory or possession of the United States; or

2 (C) For a cumulative total of 180 days from the first visit on the initial claim, a [*physician as-*
3 *stant*] **physician associate** licensed by the Oregon Medical Board in accordance with ORS 677.505
4 to 677.525 or a similarly licensed [*physician assistant*] **physician associate** in any country or in any
5 state, territory or possession of the United States.

6 (c) Except as otherwise provided for workers subject to a managed care contract, “attending
7 physician” does not include a physician who provides care in a hospital emergency room and refers
8 the injured worker to a primary care physician for follow-up care and treatment.

9 (d) “Consulting physician” means a doctor or physician who examines a worker or the worker’s
10 medical record to advise the attending physician or nurse practitioner authorized to provide
11 compensable medical services under ORS 656.245 regarding treatment of a worker’s compensable
12 injury.

13 (13)(a) “Employer” means any person, including receiver, administrator, executor or trustee, and
14 the state, state agencies, counties, municipal corporations, school districts and other public corpo-
15 rations or political subdivisions, that contracts to pay a remuneration for the services of any
16 worker.

17 (b) Notwithstanding paragraph (a) of this subsection, for purposes of this chapter, the client of
18 a temporary service provider is not the employer of temporary workers provided by the temporary
19 service provider.

20 (c) As used in paragraph (b) of this subsection, “temporary service provider” has the meaning
21 given that term in ORS 656.850.

22 (d) For the purposes of this chapter, “subject employer” means an employer that is subject to
23 this chapter as provided in ORS 656.023.

24 (14) “Insurer” means the State Accident Insurance Fund Corporation or an insurer authorized
25 under ORS chapter 731 to transact workers’ compensation insurance in this state or an assigned
26 claims agent selected by the director under ORS 656.054.

27 (15) “Consumer and Business Services Fund” means the fund created by ORS 705.145.

28 (16) “Incapacitated” means an individual is physically or mentally unable to earn a livelihood.

29 (17) “Medically stationary” means that no further material improvement would reasonably be
30 expected from medical treatment or the passage of time.

31 (18) “Noncomplying employer” means a subject employer that has failed to comply with ORS
32 656.017.

33 (19) “Objective findings” in support of medical evidence are verifiable indications of injury or
34 disease that may include, but are not limited to, range of motion, atrophy, muscle strength and
35 palpable muscle spasm. “Objective findings” does not include physical findings or subjective re-
36 sponses to physical examinations that are not reproducible, measurable or observable.

37 (20) “Palliative care” means medical service rendered to reduce or moderate temporarily the
38 intensity of an otherwise stable medical condition, but does not include those medical services ren-
39 dered to diagnose, heal or permanently alleviate or eliminate a medical condition.

40 (21) “Party” means a claimant for compensation, the employer of the injured worker at the time
41 of injury and the insurer, if any, of the employer.

42 (22) “Payroll” means a record of wages payable to workers for their services and includes
43 commissions, value of exchange labor and the reasonable value of board, rent, housing, lodging or
44 similar advantage received from the employer. However, “payroll” does not include overtime pay,
45 vacation pay, bonus pay, tips, amounts payable under profit-sharing agreements or bonus payments

1 to reward workers for safe working practices. Bonus pay is limited to payments that are not antic-
2 ipated under the contract of employment and that are paid at the sole discretion of the employer.
3 The exclusion from payroll of bonus payments to reward workers for safe working practices is only
4 for the purpose of calculations based on payroll to determine premium for workers' compensation
5 insurance, and does not affect any other calculation or determination based on payroll for the pur-
6 poses of this chapter.

7 (23) "Person" includes a partnership, joint venture, association, limited liability company and
8 corporation.

9 (24)(a) "Preexisting condition" means, for all industrial injury claims, any injury, disease, con-
10 genital abnormality, personality disorder or similar condition that contributes to disability or need
11 for treatment, provided that:

12 (A) Except for claims in which a preexisting condition is arthritis or an arthritic condition, the
13 worker has been diagnosed with the condition, or has obtained medical services for the symptoms
14 of the condition regardless of diagnosis; and

15 (B)(i) In claims for an initial injury or omitted condition, the diagnosis or treatment precedes
16 the initial injury;

17 (ii) In claims for a new medical condition, the diagnosis or treatment precedes the onset of the
18 new medical condition; or

19 (iii) In claims for a worsening pursuant to ORS 656.273 or 656.278, the diagnosis or treatment
20 precedes the onset of the worsened condition.

21 (b) "Preexisting condition" means, for all occupational disease claims, any injury, disease, con-
22 genital abnormality, personality disorder or similar condition that contributes to disability or need
23 for treatment and that precedes the onset of the claimed occupational disease, or precedes a claim
24 for worsening in such claims pursuant to ORS 656.273 or 656.278.

25 (c) For the purposes of industrial injury claims, a condition does not contribute to disability or
26 need for treatment if the condition merely renders the worker more susceptible to the injury.

27 (25) "Self-insured employer" means an employer or group of employers certified under ORS
28 656.430 as meeting the qualifications set out by ORS 656.407.

29 (26) "State Accident Insurance Fund Corporation" and "corporation" mean the State Accident
30 Insurance Fund Corporation created under ORS 656.752.

31 (27) "Wages" means the money rate at which the service rendered is recompensed under the
32 contract of hiring in force at the time of the accident, including reasonable value of board, rent,
33 housing, lodging or similar advantage received from the employer, and includes the amount of tips
34 required to be reported by the employer pursuant to section 6053 of the Internal Revenue Code of
35 1954, as amended, and the regulations promulgated pursuant thereto, or the amount of actual tips
36 reported, whichever amount is greater. The State Accident Insurance Fund Corporation may estab-
37 lish assumed minimum and maximum wages, in conformity with recognized insurance principles, at
38 which any worker shall be carried upon the payroll of the employer for the purpose of determining
39 the premium of the employer.

40 (28)(a) "Worker" means any person, other than an independent contractor, who engages to fur-
41 nish services for a remuneration, including a minor whether lawfully or unlawfully employed and
42 salaried, elected and appointed officials of the state, state agencies, counties, cities, school districts
43 and other public corporations, but does not include any person whose services are performed as an
44 adult in custody or ward of a state institution or as part of the eligibility requirements for a general
45 or public assistance grant.

1 (b) For the purpose of determining entitlement to temporary disability benefits or permanent
2 total disability benefits under this chapter, “worker” does not include a person who has withdrawn
3 from the workforce during the period for which such benefits are sought.

4 (c) For the purposes of this chapter, “subject worker” means a worker who is subject to this
5 chapter as provided in ORS 656.027.

6 (29) “Independent contractor” has the meaning given that term in ORS 670.600.

7 **SECTION 111.** ORS 656.245 is amended to read:

8 656.245. (1)(a) For every compensable injury, the insurer or the self-insured employer shall cause
9 to be provided medical services for conditions caused in material part by the injury for such period
10 as the nature of the injury or the process of the recovery requires, subject to the limitations in ORS
11 656.225, including such medical services as may be required after a determination of permanent
12 disability. In addition, for consequential and combined conditions described in ORS 656.005 (7), the
13 insurer or the self-insured employer shall cause to be provided only those medical services directed
14 to medical conditions caused in major part by the injury.

15 (b) Compensable medical services shall include medical, surgical, hospital, nursing, ambulances
16 and other related services, and drugs, medicine, crutches and prosthetic appliances, braces and
17 supports and where necessary, physical restorative services. A pharmacist or dispensing physician
18 shall dispense generic drugs to the worker in accordance with ORS 689.515. The duty to provide
19 such medical services continues for the life of the worker.

20 (c) Notwithstanding any other provision of this chapter, medical services after the worker’s
21 condition is medically stationary are not compensable except for the following:

22 (A) Services provided to a worker who has been determined to be permanently and totally dis-
23 abled.

24 (B) Prescription medications.

25 (C) Services necessary to administer prescription medication or monitor the administration of
26 prescription medication.

27 (D) Prosthetic devices, braces and supports.

28 (E) Services necessary to monitor the status, replacement or repair of prosthetic devices, braces
29 and supports.

30 (F) Services provided pursuant to an accepted claim for aggravation under ORS 656.273.

31 (G) Services provided pursuant to an order issued under ORS 656.278.

32 (H) Services that are necessary to diagnose the worker’s condition.

33 (I) Life-preserving modalities similar to insulin therapy, dialysis and transfusions.

34 (J) With the approval of the insurer or self-insured employer, palliative care that the worker’s
35 attending physician referred to in ORS 656.005 (12)(b)(A) prescribes and that is necessary to enable
36 the worker to continue current employment or a vocational training program. If the insurer or
37 self-insured employer does not approve, the attending physician or the worker may request approval
38 from the Director of the Department of Consumer and Business Services for such treatment. The
39 director may order a medical review by a physician or panel of physicians pursuant to ORS 656.327
40 (3) to aid in the review of such treatment. The decision of the director is subject to review under
41 ORS 656.704.

42 (K) With the approval of the director, curative care arising from a generally recognized, non-
43 experimental advance in medical science since the worker’s claim was closed that is highly likely
44 to improve the worker’s condition and that is otherwise justified by the circumstances of the claim.
45 The decision of the director is subject to review under ORS 656.704.

1 (L) Curative care provided to a worker to stabilize a temporary and acute waxing and waning
2 of symptoms of the worker's condition.

3 (d) When the medically stationary date in a disabling claim is established by the insurer or
4 self-insured employer and is not based on the findings of the attending physician, the insurer or
5 self-insured employer is responsible for reimbursement to affected medical service providers for
6 otherwise compensable services rendered until the insurer or self-insured employer provides written
7 notice to the attending physician of the worker's medically stationary status.

8 (e) Except for services provided under a managed care contract, out-of-pocket expense re-
9 imbursement to receive care from the attending physician or nurse practitioner authorized to pro-
10 vide compensable medical services under this section shall not exceed the amount required to seek
11 care from an appropriate nurse practitioner or attending physician of the same specialty who is in
12 a medical community geographically closer to the worker's home. For the purposes of this para-
13 graph, all physicians and nurse practitioners within a metropolitan area are considered to be part
14 of the same medical community.

15 (2)(a) The worker may choose an attending doctor, physician or nurse practitioner within the
16 State of Oregon. The worker may choose the initial attending physician or nurse practitioner and
17 may subsequently change attending physician or nurse practitioner two times without approval from
18 the director. If the worker thereafter selects another attending physician or nurse practitioner, the
19 insurer or self-insured employer may require the director's approval of the selection. The decision
20 of the director is subject to review under ORS 656.704. The worker also may choose an attending
21 doctor or physician in another country or in any state or territory or possession of the United
22 States with the prior approval of the insurer or self-insured employer.

23 (b) A medical service provider who is not a member of a managed care organization is subject
24 to the following provisions:

25 (A) A medical service provider who is not qualified to be an attending physician may provide
26 compensable medical service to an injured worker for a period of 30 days from the date of the first
27 visit on the initial claim or for 12 visits, whichever first occurs, without the authorization of an
28 attending physician. Thereafter, medical service provided to an injured worker without the written
29 authorization of an attending physician is not compensable.

30 (B) A medical service provider who is not an attending physician cannot authorize the payment
31 of temporary disability compensation. However, an emergency room physician who is not authorized
32 to serve as an attending physician under ORS 656.005 (12)(c) may authorize temporary disability
33 benefits for a maximum of 14 days. A medical service provider qualified to serve as an attending
34 physician under ORS 656.005 (12)(b)(B) may authorize the payment of temporary disability compen-
35 sation for a period not to exceed 30 days from the date of the first visit on the initial claim.

36 (C) Except as otherwise provided in this chapter, only a physician qualified to serve as an at-
37 tending physician under ORS 656.005 (12)(b)(A) or (B)(i) who is serving as the attending physician
38 at the time of claim closure may make findings regarding the worker's impairment for the purpose
39 of evaluating the worker's disability.

40 (D) Notwithstanding subparagraphs (A) and (B) of this paragraph, a nurse practitioner licensed
41 under ORS 678.375 to 678.390 or a [*physician assistant*] **physician associate** licensed by the Oregon
42 Medical Board in accordance with ORS 677.505 to 677.525 or a similarly licensed [*physician*
43 *assistant*] **physician associate** in any country or in any state, territory or possession of the United
44 States:

45 (i) May provide compensable medical services for 180 days from the date of the first visit on the

1 initial claim;

2 (ii) May authorize the payment of temporary disability benefits for a period not to exceed 180
3 days from the date of the first visit on the initial claim; and

4 (iii) When an injured worker treating with a nurse practitioner or [*physician assistant*] **physi-**
5 **cian associate** authorized to provide compensable services under this section becomes medically
6 stationary within the 180-day period in which the nurse practitioner or [*physician assistant*] **physi-**
7 **cian associate** is authorized to treat the injured worker, shall refer the injured worker to a physi-
8 cian qualified to be an attending physician as defined in ORS 656.005 for the purpose of making
9 findings regarding the worker's impairment for the purpose of evaluating the worker's disability. If
10 a worker returns to the nurse practitioner or [*physician assistant*] **physician associate** after initial
11 claim closure for evaluation of a possible worsening of the worker's condition, the nurse practitioner
12 or [*physician assistant*] **physician associate** shall refer the worker to an attending physician and the
13 insurer shall compensate the nurse practitioner or [*physician assistant*] **physician associate** for the
14 examination performed.

15 (3) Notwithstanding any other provision of this chapter, the director, by rule, upon the advice
16 of the committee created by ORS 656.794 and upon the advice of the professional licensing boards
17 of practitioners affected by the rule, may exclude from compensability any medical treatment the
18 director finds to be unscientific, unproven, outmoded or experimental. The decision of the director
19 is subject to review under ORS 656.704.

20 (4) Notwithstanding subsection (2)(a) of this section, when a self-insured employer or the insurer
21 of an employer contracts with a managed care organization certified pursuant to ORS 656.260 for
22 medical services required by this chapter to be provided to injured workers:

23 (a) Those workers who are subject to the contract shall receive medical services in the manner
24 prescribed in the contract. Workers subject to the contract include those who are receiving medical
25 treatment for an accepted compensable injury or occupational disease, regardless of the date of in-
26 jury or medically stationary status, on or after the effective date of the contract. If the managed
27 care organization determines that the change in provider would be medically detrimental to the
28 worker, the worker shall not become subject to the contract until the worker is found to be med-
29 ically stationary, the worker changes physicians or nurse practitioners, or the managed care or-
30 ganization determines that the change in provider is no longer medically detrimental, whichever
31 event first occurs. A worker becomes subject to the contract upon the worker's receipt of actual
32 notice of the worker's enrollment in the managed care organization, or upon the third day after the
33 notice was sent by regular mail by the insurer or self-insured employer, whichever event first oc-
34 curs. A worker shall not be subject to a contract after it expires or terminates without renewal. A
35 worker may continue to treat with the attending physician or nurse practitioner authorized to pro-
36 vide compensable medical services under this section under an expired or terminated managed care
37 organization contract if the physician or nurse practitioner agrees to comply with the rules, terms
38 and conditions regarding services performed under any subsequent managed care organization con-
39 tract to which the worker is subject. A worker shall not be subject to a contract if the worker's
40 primary residence is more than 100 miles outside the managed care organization's certified ge-
41 ographical area. Each such contract must comply with the certification standards provided in ORS
42 656.260. However, a worker may receive immediate emergency medical treatment that is
43 compensable from a medical service provider who is not a member of the managed care organization.
44 Insurers or self-insured employers who contract with a managed care organization for medical ser-
45 vices shall give notice to the workers of eligible medical service providers and such other informa-

1 tion regarding the contract and manner of receiving medical services as the director may prescribe.
 2 Notwithstanding any provision of law or rule to the contrary, a worker of a noncomplying employer
 3 is considered to be subject to a contract between the State Accident Insurance Fund Corporation
 4 as a processing agent or the assigned claims agent and a managed care organization.

5 (b)(A) For initial or aggravation claims filed after June 7, 1995, the insurer or self-insured em-
 6 ployer may require an injured worker, on a case-by-case basis, immediately to receive medical ser-
 7 vices from the managed care organization.

8 (B) If the insurer or self-insured employer gives notice that the worker is required to receive
 9 treatment from the managed care organization, the insurer or self-insured employer must guarantee
 10 that any reasonable and necessary services so received, that are not otherwise covered by health
 11 insurance, will be paid as provided in ORS 656.248, even if the claim is denied, until the worker
 12 receives actual notice of the denial or until three days after the denial is mailed, whichever event
 13 first occurs. The worker may elect to receive care from a primary care physician, nurse practitioner
 14 or [*physician assistant*] **physician associate** authorized to provide compensable medical services
 15 under this section who agrees to the conditions of ORS 656.260 (4)(g). However, guarantee of pay-
 16 ment is not required by the insurer or self-insured employer if this election is made.

17 (C) If the insurer or self-insured employer does not give notice that the worker is required to
 18 receive treatment from the managed care organization, the insurer or self-insured employer is under
 19 no obligation to pay for services received by the worker unless the claim is later accepted.

20 (D) If the claim is denied, the worker may receive medical services after the date of denial from
 21 sources other than the managed care organization until the denial is reversed. Reasonable and
 22 necessary medical services received from sources other than the managed care organization after
 23 the date of claim denial must be paid as provided in ORS 656.248 by the insurer or self-insured em-
 24 ployer if the claim is finally determined to be compensable.

25 (5)(a) A nurse practitioner, or a [*physician assistant*] **physician associate** described in ORS
 26 656.005 (12)(b)(C), who is not a member of the managed care organization is authorized to provide
 27 the same level of services as a primary care physician as established by ORS 656.260 (4) if the nurse
 28 practitioner or [*physician assistant*] **physician associate**:

29 (A) Maintains the worker's medical records;

30 (B) Has a documented history of treatment with the worker;

31 (C) Agrees to refer the worker to the managed care organization for any specialized treatment,
 32 including physical therapy, to be furnished by another provider that the worker may require; and

33 (D) Agrees to comply with all the rules, terms and conditions regarding services performed by
 34 the managed care organization.

35 (b)(A) A nurse practitioner or [*physician assistant*] **physician associate** authorized to provide
 36 medical services to a worker enrolled in the managed care organization may:

37 (i) Provide medical treatment to the worker if the treatment is determined to be medically ap-
 38 propriate according to the service utilization review process of the managed care organization; and

39 (ii) Authorize temporary disability payments as provided in subsection (2)(b)(D) of this section.

40 (B) The managed care organization may also authorize the nurse practitioner or [*physician as-*
 41 *stant*] **physician associate** to provide medical services and authorize temporary disability pay-
 42 ments beyond the periods established in subsection (2)(b)(D) of this section.

43 (6) Subject to the provisions of ORS 656.704, if a claim for medical services is disapproved, the
 44 injured worker, insurer or self-insured employer may request administrative review by the director
 45 pursuant to ORS 656.260 or 656.327.

1 **SECTION 112.** ORS 656.260 is amended to read:

2 656.260. (1) Any health care provider or group of medical service providers may make written
3 application to the Director of the Department of Consumer and Business Services to become certi-
4 fied to provide managed care to injured workers for injuries and diseases compensable under this
5 chapter. However, nothing in this section authorizes an organization that is formed, owned or op-
6 erated by an insurer or employer other than a health care provider to become certified to provide
7 managed care.

8 (2) Each application for certification shall be accompanied by a reasonable fee prescribed by the

17 (b) A description of the times, places and manner of providing services under the plan.

18 (c) A description of the times, places and manner of providing other related optional services
19 the applicants wish to provide.

20 (d) Satisfactory evidence of ability to comply with any financial requirements to insure delivery
21 of service in accordance with the plan which the director may prescribe.

22 (4) The director shall certify a health care provider or group of medical service providers to
23 provide managed care under a plan if the director finds that the plan:

24 (a) Proposes to provide medical and health care services required by this chapter in a manner
25 that:

26 (A) Meets quality, continuity and other treatment standards adopted by the health care provider
27 or group of medical service providers in accordance with processes approved by the director; and

28 (B) Is timely, effective and convenient for the worker.

29 (b) Subject to any other provision of law, does not discriminate against or exclude from partic-
30 ipation in the plan any category of medical service providers and includes an adequate number of
31 each category of medical service providers to give workers adequate flexibility to choose medical
32 service providers from among those individuals who provide services under the plan. However,
33 nothing in the requirements of this paragraph shall affect the provisions of ORS 441.055 relating to
34 the granting of medical staff privileges.

35 (c) Provides appropriate financial incentives to reduce service costs and utilization without
36 sacrificing the quality of service.

37 (d) Provides adequate methods of peer review, service utilization review, quality assurance,
38 contract review and dispute resolution to ensure appropriate treatment or to prevent inappropriate
39 or excessive treatment, to exclude from participation in the plan those individuals who violate these
40 treatment standards and to provide for the resolution of such medical disputes as the director con-
41 siders appropriate. A majority of the members of each peer review, quality assurance, service utili-
42 zation and contract review committee shall be physicians licensed to practice medicine by the
43 Oregon Medical Board. As used in this paragraph:

44 (A) "Peer review" means evaluation or review of the performance of colleagues by a panel with
45 similar types and degrees of expertise. Peer review requires participation of at least three physicians

1 prior to final determination.

2 (B) "Service utilization review" means evaluation and determination of the reasonableness, ne-
3 cessity and appropriateness of a worker's use of medical care resources and the provision of any
4 needed assistance to clinician or member, or both, to ensure appropriate use of resources. "Service
5 utilization review" includes prior authorization, concurrent review, retrospective review, discharge
6 planning and case management activities.

7 (C) "Quality assurance" means activities to safeguard or improve the quality of medical care
8 by assessing the quality of care or service and taking action to improve it.

9 (D) "Dispute resolution" includes the resolution of disputes arising under peer review, service
10 utilization review and quality assurance activities between insurers, self-insured employers, workers
11 and medical and health care service providers, as required under the certified plan.

12 (E) "Contract review" means the methods and processes whereby the managed care organization
13 monitors and enforces its contracts with participating providers for matters other than matters
14 enumerated in subparagraphs (A), (B) and (C) of this paragraph.

15 (e) Provides a program involving cooperative efforts by the workers, the employer and the
16 managed care organizations to promote workplace health and safety consultative and other services
17 and early return to work for injured workers.

18 (f) Provides a timely and accurate method of reporting to the director necessary information
19 regarding medical and health care service cost and utilization to enable the director to determine
20 the effectiveness of the plan.

21 (g)(A) Authorizes workers to receive compensable medical treatment from a primary care phy-
22 sician or chiropractic physician who is not a member of the managed care organization, but who
23 maintains the worker's medical records and is a physician with whom the worker has a documented
24 history of treatment, if:

25 (i) The primary care physician or chiropractic physician agrees to refer the worker to the
26 managed care organization for any specialized treatment, including physical therapy, to be furnished
27 by another provider that the worker may require;

28 (ii) The primary care physician or chiropractic physician agrees to comply with all the rules,
29 terms and conditions regarding services performed by the managed care organization; and

30 (iii) The treatment is determined to be medically appropriate according to the service utilization
31 review process of the managed care organization.

32 (B) Nothing in this paragraph is intended to limit the worker's right to change primary care
33 physicians or chiropractic physicians prior to the filing of a workers' compensation claim.

34 (C) A chiropractic physician authorized to provide compensable medical treatment under this
35 paragraph may provide services and authorize temporary disability compensation as provided in ORS
36 656.005 (12)(b)(B) and 656.245 (2)(b). However, the managed care organization may authorize

42 (h) Provides a written explanation for denial of participation in the managed care organization
43 plan to any licensed health care provider that has been denied participation in the managed care
44 organization plan.

45 (i) Does not prohibit the injured worker's attending physician from advocating for medical ser-

1 vices and temporary disability benefits for the injured worker that are supported by the medical
2 record.

3 (j) Complies with any other requirement the director determines is necessary to provide quality
4 medical services and health care to injured workers.

5 (5)(a) Notwithstanding ORS 656.245 (5) and subsection (4)(g) of this section, a managed care or-
6 ganization may deny or terminate the authorization of a primary care physician or chiropractic
7 physician to serve as an attending physician under subsection (4)(g) of this section or of a nurse
8 practitioner or [*physician assistant*] **physician associate** to provide medical services as provided in
9 ORS 656.245 (5) if the physician, nurse practitioner or [*physician assistant*] **physician associate**,

32 other than an attending physician pursuant to ORS 656.245 (2)(b) shall be subject to review by the
33 director or the director's designated representatives. The decision of the director is subject to re-

22 care provider is dissatisfied with an action of the managed care organization regarding the provision
23 of medical services pursuant to this chapter, peer review, service utilization review or quality as-
24 surance activities, that person or entity must first apply to the director for administrative review
25 of the matter before requesting a hearing. Such application must be made not later than the 60th
26 day after the date the managed care organization has completed and issued its final decision.

27 (16) Upon a request for administrative review, the director shall create a documentary record
28 sufficient for judicial review. The director shall complete administrative review and issue a pro-

45 (20) The director shall conduct such investigations, audits and other administrative oversight in

14 gally entitled to recover such damages, and if so, the amount thereof, shall be made by agreement
15 between the insured and the insurer, or, in the event of disagreement, may be determined by arbi-
16 tration as provided in subsection (10) of this section.

17 (b) No judgment against any person or organization alleged to be legally responsible for bodily
18 injury, except for proceedings instituted against the insurer as provided in this policy, shall be
19 conclusive, as between the insured and the insurer, on the issues of liability of the person or or-

15 motor vehicle accident that is caused by a vehicle that has no physical contact with the insured or
16 the vehicle the insured is occupying at the time of the accident, provided:

17 (A) The identity of either the operator or the owner of the phantom vehicle cannot be ascer-
18 tained;

19 (B) The facts of the accident can be corroborated by competent evidence other than the testi-
20 mony of the insured or any person having an uninsured motorist claim resulting from the accident;

22 (C) The insured or someone on behalf of the insured reported the accident within 72 hours to
23 a police, peace or judicial officer, to the Department of Transportation or to the equivalent depart-

7 or organization legally responsible for the use of the vehicle, or with respect to which there is
8 collectible bodily injury liability insurance applicable at the time of the accident but the insurance
9 company writing the insurance denies coverage or the company writing the insurance becomes vol-
10 untarily or involuntarily declared bankrupt or for which a receiver is appointed or becomes insol-
11 vent. It shall be a disputable presumption that a vehicle is uninsured in the event the insured and
12 the insurer, after reasonable efforts, fail to discover within 90 days from the date of the accident,
13 the existence of a valid and collectible motor vehicle bodily injury liability insurance applicable at
14 the time of the accident.

15 (B) A hit-and-run vehicle.

16 (C) A phantom vehicle.

17 (D) A stolen vehicle.

18 (E) A vehicle that is owned or operated by a self-insurer:

19 (i) That is not in compliance with ORS 806.130 (1)(c); or

20 (ii) That provides recovery to an insured in an amount that is less than the sums that the in-
21 sured or the heirs or legal representative of the insured is legally entitled to recover as damages
22 for bodily injury or death that is caused by accident and that arises out of owning, maintaining or
23 using an uninsured vehicle.

24 (L) "Uninsured vehicle" does not include:

25 (A) An insured vehicle, unless the vehicle is a stolen vehicle;

26 (B) Except as provided in paragraph (k)(E) of this subsection, a vehicle that is owned or oper-
27 ated by a self-insurer within the meaning of any motor vehicle financial responsibility law, motor
28 carrier law or any similar law;

29 (C) A vehicle that is owned by the United States of America, Canada, a state, a political sub-
30 division of any such government or an agency of any such government;

31 (D) A land motor vehicle or trailer, if operated on rails or crawler-treads or while located for
32 use as a residence or premises and not as a vehicle;

33 (E) A farm-type tractor or equipment designed for use principally off public roads, except while
34 actually upon public roads; or

35 (F) A vehicle owned by or furnished for the regular or frequent use of the insured or any
36 member of the household of the insured.

37 (m) "Vehicle" means every device in, upon or by which any person or property is or may be
38 transported or drawn upon a public highway, but does not include devices moved by human power
39 or used exclusively upon stationary rails or tracks.

40 (3) This coverage applies only to accidents that occur on and after the effective date of the
41 policy, during the policy period and within the United States of America, its territories or pos-
42 sessions, or Canada.

43 (4)(a) This coverage does not apply to bodily injury of an insured with respect to which the in-
44 sured or the legal representative of the insured shall, without the written consent of the insurer,
45 make any settlement with or prosecute to judgment any action against any person or organization

1 who may be legally liable therefor.

2 (b) This coverage does not apply to bodily injury to an insured while occupying a vehicle, other
3 than an insured vehicle, owned by, or furnished for the regular use of, the named insured or any
4 relative resident in the same household, or through being struck by the vehicle.

5 (c) This coverage does not apply so as to inure directly or indirectly to the benefit of any
6 workers' compensation carrier, any person or organization qualifying as a self-insurer under any
7 workers' compensation or disability benefits law or any similar law or the State Accident Insurance
8 Fund Corporation.

9 (d) This coverage does not apply with respect to underinsured motorist benefits unless:

10 (A) The limits of liability under any bodily injury liability insurance applicable at the time of
11 the accident regarding the injured person have been exhausted by payment of judgments or settle-
12 ments to the injured person or other injured persons;

13 (B) The described limits have been offered in settlement, the insurer has refused consent under
14 paragraph (a) of this subsection and the insured protects the insurer's right of subrogation to the
15 claim against the tortfeasor;

16 (C) The insured gives credit to the insurer for the unrealized portion of the described liability
17 limits as if the full limits had been received if less than the described limits have been offered in
18 settlement, and the insurer has consented under paragraph (a) of this subsection; or

19 (D) The insured gives credit to the insurer for the unrealized portion of the described liability
20 limits as if the full limits had been received if less than the described limits have been offered in
21 settlement and, if the insurer has refused consent under paragraph (a) of this subsection, the insured
22 protects the insurer's right of subrogation to the claim against the tortfeasor.

23 (e) When seeking consent under paragraph (a) or (d) of this subsection, the insured shall allow
24 the insurer a reasonable time in which to collect and evaluate information related to consent to the
25 proposed offer of settlement. The insured shall provide promptly to the insurer any information that
26 is reasonably requested by the insurer and that is within the custody and control of the insured.
27 Consent will be presumed to be given if the insurer does not respond within a reasonable time. For
28 purposes of this paragraph, a "reasonable time" is no more than 30 days from the insurer's receipt
29 of a written request for consent, unless the insured and the insurer agree otherwise.

30 (5)(a) As soon as practicable, the insured or other person making claim shall give to the insurer
31 written proof of claim, under oath if required, including full particulars of the nature and extent of
32 the injuries, treatment and other details entering into the determination of the amount payable
33 hereunder. The insured and every other person making claim hereunder shall submit to examinations
34 under oath by any person named by the insurer and subscribe the same, as often as may reasonably
35 be required. Proof of claim shall be made upon forms furnished by the insurer unless the insurer fails
36 to furnish the forms within 15 days after receiving notice of claim.

37 (b) Upon reasonable request of and at the expense of the insurer, the injured person shall submit
38 to physical examinations by physicians, naturopathic physicians, [*physician assistants*] **physician**
39 **associates** or nurse practitioners selected by the insurer and shall, upon each request from the
40 insurer, execute authorization to enable the insurer to obtain medical reports and copies of records.

41 (6) If, before the insurer makes payment of loss hereunder, the insured or the legal represen-

44 complaint or other process served in connection with the legal action shall be forwarded imme-
45 diately to the insurer by the insured or the legal representative of the insured.

1 (7)(a) The limit of liability stated in the declarations as applicable to “each person” is the limit
2 of the insurer’s liability for all damages because of bodily injury sustained by one person as the
3 result of any one accident and, subject to the above provision respecting each person, the limit of
4 liability stated in the declarations as applicable to “each accident” is the total limit of the
5 company’s liability for all damages because of bodily injury sustained by two or more persons as the
6 result of any one accident.

7 (b) Any amount payable under the terms of this coverage because of bodily injury sustained in
8 an accident by a person who is an insured under this coverage shall be reduced by the amount paid
9 and the present value of all amounts payable on account of the bodily injury under any workers’

16 paid to the injured person. If liability proceeds have been offered and not paid, the amount payable
17 under the terms of the coverage shall include the amount of liability limits offered but not accepted
18 due to the insurer’s refusal to consent. The insured shall cooperate so as to permit the insurer to
19 proceed by subrogation or assignment to prosecute the claim against the uninsured motorist.

20 (8) No action shall lie against the insurer unless, as a condition precedent thereto, the insured
21 or the legal representative of the insured has fully complied with all the terms of this policy.

22 (9)(a) With respect to bodily injury to an insured:

23 (A) While occupying a vehicle owned by a named insured under this coverage, the insurance
24 under this coverage is primary.

25 (B) While occupying a vehicle not owned by a named insured under this coverage, the insurance
26 under this coverage shall apply only as excess insurance over any primary insurance available to
27 the occupant that is similar to this coverage, and this excess insurance coverage shall then apply

30 of owning, maintaining or using an uninsured vehicle.

33 over any other insurance available to the insured that is similar to this coverage, and this excess
34 insurance coverage shall then apply only to the amount by which the applicable limit of liability of
35 this coverage exceeds the sum of the applicable limits of liability of all other insurance.

36 (10) If any person making claim hereunder and the insurer do not agree that the person is le-
37 gally entitled to recover damages from the owner or operator of an uninsured vehicle because of
38 bodily injury to the insured, or do not agree as to the amount of payment that may be owing under
39 this coverage, then, in the event the insured and the insurer elect by mutual agreement at the time
40 of the dispute to settle the matter by arbitration, the arbitration shall take place as described in
41 ORS 742.505. Any judgment upon the award rendered by the arbitrators may be entered in any court
42 having jurisdiction thereof, provided, however, that the costs to the insured of the arbitration pro-

20 legal action against any or all persons claimed to be liable to the insured for the injuries. If the
21 insured elects to receive payment from the insurer under this coverage, then the insured shall hold
22 in trust for the benefit of the insurer all rights of recovery the insured shall have against any other
23 person, firm or organization because of the damages that are the subject of claim made under this
24 coverage, but only to the extent of the actual payment made by the insurer;

25 (d) The person shall do whatever is proper to secure and shall do nothing after loss to prejudice

27 (e) If requested in writing by the insurer, the person shall take, through any representative not
28 in conflict in interest with the person, designated by the insurer, such action as may be necessary

31 hereunder. In the event of a recovery, the insurer shall be reimbursed out of the recovery for ex-

36 (12)(a) The parties to this coverage agree that no cause of action shall accrue to the insured
37 under this coverage unless within two years from the date of the accident:

38 (A) Agreement as to the amount due under the policy has been concluded;

40 (C) The insured has filed an action against the insurer; or

41 (D) Suit for bodily injury has been filed against the uninsured motorist and, within two years

45 (A) "Date of settlement" means the date on which a written settlement agreement or release is

18 physician licensed under ORS chapter 685, a *[physician assistant]* **physician associate** licensed un-
19 der ORS 677.505 to 677.525 or a nurse practitioner licensed under ORS 678.375 to 678.390 that the
20 owner is of sound mind and under no constraint or undue influence to enter into a life settlement
21 contract; and

22 (B) A document in which the insured consents to the release of the insured's medical records
23 to a licensed life settlement provider, life settlement broker and the insurance company that issued
24 the life insurance policy covering the life of the insured.

25 (b) Within 20 days after an owner executes documents necessary to transfer any rights under
26 an insurance policy or, if the insured is terminally ill, within 20 days after an owner entering any
27 agreement, option, promise or any other form of understanding, expressed or implied, to transfer the
28 policy for value, the life settlement provider shall give written notice to the insurer that issued the
29 insurance policy that the policy has or will become a settled policy. The notice must be accompanied
30 by the documents required by paragraph (c) of this subsection.

31 (c) The life settlement provider shall deliver a copy of the medical release required under par-
32 agraph (a)(B) of this subsection, a copy of the owner's application for the life settlement contract,
33 the notice required under paragraph (b) of this subsection and a request for verification of coverage
34 to the insurer that issued the life policy that is the subject of the life transaction. The Director of
35 the Department of Consumer and Business Services shall develop and approve a form for the request
36 for verification.

37 (d) The insurer shall respond to a request for verification of coverage submitted on an approved
38 form by a life settlement provider or life settlement broker within 30 calendar days of the date the
39 request is received and shall indicate whether, based on the medical evidence and documents pro-

41 surance contract or possible fraud. The insurer shall accept a request for verification of coverage

13 (3)(a) All life settlement contracts entered into in this state must provide the owner with an
14 absolute right to rescind the contract before the earlier of 60 calendar days after the date upon
15 which the life settlement contract is executed by all parties or 30 calendar days after the life
16 settlement proceeds have been sent to the owner under subsection (5) of this section.

17 (b) The life settlement provider may condition rescission upon the owner both giving notice and

44 policy issuance, the following conditions are met:

45 (A) Policy premiums have been funded exclusively with unencumbered assets, including an in-

1 terest in the life insurance policy being financed only to the extent of its net cash surrender value,
2 provided by, or full recourse liability incurred by, the insured or a person closely related to the in-
3 sured by blood or law or a party having a lawful substantial economic interest in the continued life,
4 health and bodily safety of the person insured, or a trust established primarily for the benefit of such

10 **ate**, nurse practitioner, audiologist, hearing aid specialist, speech-language pathologist, rehabili-
11 tation instructor for persons who are blind or vocational rehabilitation counselor of the Department
12 of Human Services. Certification implies that the individual cannot use the telephone for expressive
13 or receptive communication.

14 (b) No more than one assistive telecommunication device or adaptive equipment device may be
15 provided to a household. However, two assistive telecommunication devices or adaptive equipment
16 devices may be provided to a household if more than one eligible person permanently resides in the
17 household. Households without any assistive telecommunication devices or adaptive equipment shall
18 be given priority over households with one assistive telecommunication device or adaptive equip-
19 ment device when such devices are distributed.

20 (c) ORS 759.693 to 759.698 do not require a telecommunications utility to provide an assistive
21 telecommunication device to any person in violation of ORS 646.730.

22 (2)(a) In order to be eligible to receive adaptive equipment, individuals must be certified to have
23 the required disability by a person or agency designated by the Public Utility Commission to make
24 such certifications. Certification implies that the individual is unable to use the telephone.

25 (b) ORS 759.693 to 759.698 do not require a telecommunications utility to provide adaptive
26 equipment to any person in violation of ORS 646.730.

27 **SECTION 166.** ORS 807.090 is amended to read:

28 807.090. (1) If the Department of Transportation determines that a person may be ineligible for
29 a license because the person has a mental or physical condition or impairment that affects the
30 person’s ability to safely operate a motor vehicle, the person may establish eligibility for a license:

31 (a) By personally demonstrating to the satisfaction of the department that, notwithstanding the
32 mental or physical condition or impairment, the person is qualified to safely operate a motor vehicle;
33 or

34 (b) If the department reasonably believes that, notwithstanding the demonstration under para-
35 graph (a) of this subsection, the person’s mental or physical condition or impairment affects the
36 person’s ability to safely operate a motor vehicle, by receiving a determination of eligibility from the

38 (2) The medical determination officer shall determine that a person is eligible for a license under
39 this section if an applicant establishes to the satisfaction of the officer that the person’s mental or

42 under this subsection:

43 (a) A report from the person’s physician, nurse practitioner or [*physician assistant*] **physician**
44 **associate** of the person’s condition or impairment.

45 (b) If the person’s condition or impairment apparently involves only visual deficiencies, the de-

1 partment may require a person to submit a report from a licensed optometrist or a licensed physi-
 2 cian who specializes in diagnosis and treatment of diseases of the eye.

3 (c) The medical determination officer may require an examination and a written report of
 4 findings and recommendations from a qualified physician, nurse practitioner or [*physician assistant*]
 5 **physician associate** identified by the officer in addition to other reports submitted.

6 (3) If a person establishes eligibility for a license under this section by receiving a determination
 7 of eligibility, the department may require the person to reestablish eligibility at reasonable intervals.
 8 The frequency of reestablishing eligibility under this subsection shall be established by the medical
 9 determination officer after reviewing any recommendations from the physician, nurse practitioner
 10 or [*physician assistant*] **physician associate** of the person required to reestablish eligibility.

11 (4) The department may employ any qualified physician, nurse practitioner or [*physician assist-*
 12 *ant*] **physician associate** who holds an unrestricted license in the State of Oregon to perform the
 13 duties assigned to the medical determination officer by this section.

14 (5) As used in this section, “physician” means a person who holds a degree of Doctor of Medi-
 15 cine or Doctor of Osteopathic Medicine and is licensed under ORS 677.100 to 677.228 and a person
 16 who holds a degree of Doctor of Naturopathic Medicine and is licensed under ORS chapter 685.

18 811.220. The Director of Transportation shall issue a certificate of exemption required under
 19 ORS 811.215 for any person on whose behalf a statement signed by a physician, nurse practitioner
 20 or [*physician assistant*] **physician associate** is presented to the Department of Transportation. For
 21 a physician’s, nurse practitioner’s or [*physician assistant’s*] **physician associate’s** statement to
 22 qualify under this section, the physician, nurse practitioner or [*physician assistant*] **physician as-**
 23 **sociate** giving the statement must set forth reasons in the statement why use of a child safety sys-
 24 tem, safety belt or safety harness by the person would be impractical or harmful to the person by
 25 reason of physical condition, medical problem or body size.

26 **SECTION 168.** ORS 811.604 is amended to read:

27 811.604. Application for issuance or renewal of a disabled person parking permit in the form of
 28 an individual placard or decal issued under ORS 811.602 shall include:

29 (1) A certificate, signed and dated within six months preceding the date of application, by a li-
 30 censed physician, a licensed nurse practitioner or a licensed [*physician assistant*] **physician asso-**
 31 **ciate** to the Department of Transportation that the applicant is a person with a disability or a
 32 certificate, signed and dated within six months preceding the date of application, by a licensed
 33 optometrist that the applicant is a person with a disability because of loss of vision or substantial
 34 loss of visual acuity or visual field beyond correction;

35 (2) The state-issued licensing number of the licensed physician, certified nurse practitioner, li-
 36 censed [*physician assistant*] **physician associate** or licensed optometrist who signed the certificate
 37 described in subsection (1) of this section; and

38 (3) The number of a driver license, driver permit, identification card or parking identification
 39 card issued to the applicant by the department.

41 811.611. (1) The Department of Transportation may issue a disabled person parking permit in the
 42 form of a placard to a person who is visiting from a foreign country if the person presents to the
 43 department either a valid driver license or other grant of driving privileges from the foreign country
 44 or a passport or visa showing that the person is a visitor to the United States and presents one of
 45 the following:

1 (a) A valid disabled person parking permit issued by the country that issued the visitor's pass-
2 port or visa;

3 (b) A certificate from an official of the agency that issues disabled person parking permits in the
4 country that issued the visitor's passport or visa certifying that the person holds a valid disabled
5 person parking permit; or

6 (c) A certificate from a licensed physician, a licensed nurse practitioner or a licensed [*physician*

39 assistant] **physician associate** enters into a collaboration agreement, as defined in ORS 677.495. A
40 [physician assistant] **physician associate** described in this section:

41 (1) May enter into a collaboration agreement on or after July 15, 2022.

42 (2) Shall enter into a collaboration agreement not later than the date on which the [physician
43 assistant's] **physician associate's** license is due for renewal or December 31, 2023, whichever is
44 later.
