## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act makes changes to certain Oregon tax laws. It takes effect on the 91st day after session ends. (Flesch Readability Score: 76.9).

Makes technical, policy and administrative changes to certain Oregon tax laws.

Takes effect on the 91st day following adjournment sine die.

**SECTION 2.** Section 17, chapter 579, Oregon Laws 2019, as amended by section 13, chapter 490, Oregon Laws 2023, and section 4, chapter 545, Oregon Laws 2023, is amended to read:

**Sec. 17.** (1) ORS 315.591 to 315.603 apply to tax years beginning on or after January 1, 2020, and before January 1, 2030.

(2) Except as provided in ORS 315.593 (6), a credit may not be claimed under ORS 315.593 for tax years beginning on or after January 1, 2030.

(3) The amendments to ORS 315.591, 315.593 and 315.595 by sections 1 to 3, **chapter 545, Oregon Laws 2023**, [*of this 2023 Act*] apply to tax years beginning on or after January 1, 2024, and before January 1, [*2026*] **2030**.

**SECTION 3.** Section 1, chapter 423, Oregon Laws 2023, is amended to read:

**Sec. 1.** (1)(a) Outstanding ad valorem property taxes, and interest on the taxes, assessed on real property[, *the ownership of which was transferred, from the federal government to a port district*

1 *formed under ORS chapter 777,]* **described in paragraph (b) of this subsection** by the assessor of  
2 the county in which the real property is located, are hereby canceled.

3 **(b) This subsection applies to property in which the federal government held a leasehold**  
4 **interest, from a port district formed under ORS chapter 777, that was terminated.**

5 (2) Ad valorem property taxes, and interest on the taxes, assessed on real property owned by a  
6 port without a working waterfront formed under ORS chapter 777, that have been outstanding since  
7 a date prior to January 1, 2012, are hereby canceled, provided the tax collector of the county in  
8 which the property is located has exhausted all remedies provided by law for collection of the taxes  
9 and interest.

10 **SECTION 4.** Section 2, chapter 423, Oregon Laws 2023, is amended to read:

16 (2) The amendments to sections 3 and 5, chapter 589, Oregon Laws 2021, by sections 3 and 4,  
17 **chapter 82, Oregon Laws 2022**, *[of this 2022 Act]* apply to tax years beginning on or after January  
18 1, 2022, and before January 1, **[2024] 2026**, and to estimated payments due on and after June 15, 2022.

19 (3) The amendments to section 2, chapter 527, Oregon Laws 2021, by section 8, **chapter 82,**

29 **SECTION 6. ORS 315.283 applies to sales of publicly supported housing completed in tax**  
30 **years beginning on or after January 1, 2024, and before January 1, 2030.**

31 **SECTION 7.** ORS 315.283 is amended to read:

32 315.283. (1) A taxpayer is allowed a credit against the taxes otherwise due under ORS chapter  
33 316 or, if the taxpayer is a corporation, under ORS chapter 317 or 318 for a qualifying sale in  
34 Oregon of publicly supported housing during the tax year. The amount of the credit allowed under  
35 this section may not exceed:

36 (a) For housing owned by the taxpayer for at least five years, 2.5 percent of the lesser of the  
37 housing's sale price or the appraisal under ORS 315.286 (2)(e); or

38 (b) For housing owned by the taxpayer for at least 10 years, five percent of the lesser of the  
39 housing's sale price or the appraisal under ORS 315.286 (2)(e).

40 (2) In order to claim a credit under this section, a taxpayer must:

41 (a) Lack identity of interest with the purchaser; and

42 (b) Receive certification of a credit under ORS 315.286 (6) and submit the certification to the  
43 Department of Revenue upon request of the department.

44 (3) The Department of Revenue may:

45 (a) Adopt rules for carrying out the provisions of this section; and

1 (b) Prescribe the form used to claim a credit under this section and the information required  
2 on the form.

3 (4) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a  
4 particular tax year may be carried forward and offset against the taxpayer's tax liability for the next  
5 succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried  
6 forward and used in the second succeeding tax year, and likewise any credit not used in that second  
7 succeeding tax year may be carried forward and used in the third succeeding tax year, but may not  
8 be carried forward for any tax year thereafter.

9 (5) In the case of a credit allowed under this section:

10 (a) A nonresident is allowed the credit under this section in the proportion provided in ORS  
11 316.117.

12 (b) If a change in the status of a taxpayer from resident to nonresident or from nonresident to  
13 resident occurs, the credit allowed by this section must be determined in a manner consistent with  
14 ORS 316.117.

15 (c) If a change in the tax year of a taxpayer occurs as described in ORS 314.085, or if the De-  
16 partment of Revenue terminates the taxpayer's tax year under ORS 314.440, the credit allowed under  
17 this section must be prorated or computed in a manner consistent with ORS 314.085.

18 **(6) The Housing and Community Services Department shall provide information to the**  
19 **Department of Revenue about all certifications issued under this section, if required as pro-**  
20 **vided by ORS 315.058.**

25 **SECTION 9.** ORS 285B.627 is amended to read:

26 285B.627. (1) In consultation with the Department of Revenue, the Oregon Business Development  
27 Department shall establish and administer the Oregon Industrial Site Readiness Program. The pur-  
28 pose of the program is to:

29 (a) Enter into tax reimbursement arrangements with qualified project sponsors pursuant to  
30 subsection (5) of this section; or

31 (b) Provide loans, including forgivable loans, to qualified project sponsors pursuant to subsection  
32 (5) of this section.

33 (2)(a) Subject to standards and procedures that the Oregon Business Development Department  
34 shall establish by rule, the department shall designate regionally significant industrial sites for  
35 inclusion in the program.

36 (b) A regionally significant industrial site designated under this section must be an industrial  
37 site that is planned and zoned for industrial use.

38 (3) A project sponsor may apply to participate in the program by submitting an application and  
39 development plan in writing in a form prescribed by the department by rule.

40 (4) The department shall establish by rule criteria and standards for the qualification of project  
41 sponsors to participate in the program.

42 *[(5) Upon qualification of a project sponsor under this section, and before July 1, 2023, the de-*  
43 *partment may:]*

44 **(5) Upon qualification of a project sponsor under this section, and before December 31,**  
45 **2029, the department may:**

1 (a) Enter into a tax reimbursement arrangement with the project sponsor pursuant to which the  
2 project sponsor shall receive an amount equal to 50 percent of the estimated incremental income tax  
3 revenues generated by an eligible employer per tax year, beginning with the first tax year following  
4 the tax year in which a project sponsor is qualified under this section, until the total investment  
5 of the qualified project sponsor in the eligible site preparation costs, including interest, established  
6 under subsection (7) of this section has been recovered, at which time the tax reimbursement ar-  
7 rangement shall end; or

8 (b) Enter into a loan agreement with the project sponsor under terms and conditions specified  
9 and required by the department. In making a determination to enter into a loan agreement with the  
10 project sponsor, the department shall consider the reasonableness of the project sponsor's estimated  
11 costs to prepare the site for industrial use, including but not limited to eligible site preparation  
12 costs established by the department pursuant to subsection (7) of this section. The agreement may  
13 specify that a portion of the loan may be forgiven if the project sponsor enters into a contract with  
14 an eligible employer to conduct a business in the traded sector industry on a regionally significant  
15 industrial site within seven years after the project sponsor was qualified under this section.

16 (6)(a) The total amount of the loan that may be forgiven under subsection (5) of this section is  
17 the lesser of:

18 (A) Fifty percent of the total cost of eligible site preparation costs; or

19 (B) Fifty percent of the amount of the estimated incremental income tax revenues for the eligible  
20 employer for the term of the loan.

21 (b) Loan forgiveness may not be allowed under subsection (5) of this section if any portion of  
22 the loan that would not be forgiven would be repaid by the project sponsor with state funds received  
23 from any source.

24 (7) The department shall establish, by rule, eligible site preparation costs including, but not  
25 limited to, some or all of the following:

26 (a) Acquisition and assembly costs associated with creating large development parcels.

27 (b) Transportation improvements such as access roads, intersections, turning lanes, signals,  
28 sidewalks, curbs, transit stops and storm drains.

29 (c) Water and sewer infrastructure.

30 (d) Natural resource mitigation.

31 (e) Site grading activities.

32 (f) Environmental remediation and mitigation activities to address brownfields issues in accord-  
33 ance with state and federally approved remediation plans.

34 (g) Planning, engineering and administrative costs associated with applying for necessary local,  
35 state and federal permits.

36 (h) Interest-carrying costs incurred by a project sponsor for amounts borrowed to develop a re-  
37 gionally significant industrial site, not to exceed 20 percent of the total amount forgiven, if any,  
38 under subsection (5) of this section.

39 (8) The total amount of tax reimbursement arrangements [*and loan amounts*] authorized under  
40 this section may not exceed \$10 million per year.

41 (9) Funds received pursuant to a tax reimbursement arrangement or a loan agreement under  
42 subsection (5) of this section may not be used for the payment of:

43 (a) A penalty or fine; or

44 (b) Environmental remediation activities conducted at a regionally significant industrial site that  
45 is listed or proposed to be listed as a national priority pursuant to the Comprehensive Environ-

1 mental Response, Compensation, and Liability Act of 1980 (42 U.S.C. 9605) for which the project  
2 sponsor, eligible employer or any party to the tax reimbursement arrangement or loan agreement  
3 is liable under 42 U.S.C. 9607 at that regionally significant industrial site.

4 (10) The department shall adopt rules to administer and implement the provisions of this section.

5 **SECTION 10.** ORS 285B.626 is amended to read:

6 285B.626. As used in ORS 285B.625 to 285B.632:

7 (1) "Eligible employer" means an employer that:

8 (a) Is conducting a traded sector business on a regionally significant industrial site; and

9 (b)(A) With respect to **the employer's establishment at** a rural site, has [*hired at least 25*  
10 *full-time employees whose wages average*] **increased average annual employment by at least 25**  
11 **jobs and has an average annual wage of** at least 150 percent of the county or state average wage,  
12 whichever is less; or

13 (B) With respect to **the employer's establishment at** an urban site, has [*hired at least 50 full-*  
14 *time employees whose wages average*] **increased average annual employment by at least 50 jobs**  
15 **and has an average annual wage of** at least 150 percent of the county or state average wage,  
16 whichever is less.

17 (2) "Estimated incremental income tax revenues" means the Oregon personal income tax reven-  
18 ues that are equivalent to the amount of tax that employees of an eligible employer who are hired  
19 by the eligible employer on a designated regionally significant industrial site have paid under ORS  
20 chapter 316 in the tax years following the first tax year in which the eligible employer begins con-  
21 ducting a traded sector business on the designated regionally significant industrial site.

22 (3) "Industrial use" means employment activities, including but not limited to manufacturing,  
23 assembly, fabrication, processing, storage, logistics, warehousing, importation, distribution, trans-  
24 shipment and research and development, that generate income from the production, handling or  
25 distribution of goods or services, including goods or services in the traded sector.

26 (4) "Project sponsor" means:

27 (a) A public owner of a regionally significant industrial site that is investing in preparation of  
28 the site for industrial use by a third party; or

29 (b) A public entity that has entered into a development or other agreement with the private  
30 owner of a regionally significant industrial site to prepare the site for industrial use.

31 (5) "Regionally significant industrial site" means a site planned and zoned for industrial use  
32 that:

33 (a)(A) Is suitable for the location of new industrial uses or the expansion of existing industrial  
34 uses and that can provide significant additional employment in the region;

35 (B) Has site characteristics that provide significant competitive advantages that are difficult or  
36 impossible to replicate in the region; and

37 (C) Has superior access to transportation and freight infrastructure, including but not limited  
38 to rail, port, airport, multimodal freight or transshipment facilities and other major transportation  
39 facilities or routes; or

40 (b) Is located in an area designated by Metro, as defined in ORS 197.015, as a regionally sig-  
41 nificant industrial area.

42 (6) "Rural site" means a regionally significant industrial site located in an area outside of a  
43 metropolitan statistical area, as defined by the most recent federal decennial census.

44 (7) "Traded sector" has the meaning given that term in ORS 285A.010.

45 (8) "Urban site" means a regionally significant industrial site located in a metropolitan statis-

1 tical area, as defined by the most recent federal decennial census, that is located inside a regional  
2 or metropolitan urban growth boundary.

3 (9) “Wage” has the meaning given that term pursuant to rules adopted by the Oregon Business  
4 Development Department.

8 **SECTION 11. ORS 307.157 is repealed.**

9 **SECTION 12. ORS 311.702, 311.704, 311.706, 311.708, 311.711, 311.716, 311.718, 311.721,  
10 311.722, 311.723, 311.725, 311.727, 311.729, 311.730, 311.731, 311.732 and 311.735 are repealed.**

11 **SECTION 13. Notwithstanding the repeal of ORS 311.702, 311.704, 311.706, 311.708, 311.711,  
12 311.716, 311.718, 311.721, 311.722, 311.723, 311.725, 311.727, 311.729, 311.730, 311.731, 311.732 and  
13 311.735 by section 12 of this 2024 Act, all balances deferred under ORS 311.702 to 311.735 that  
14 remain outstanding on the effective date of this 2024 Act shall remain due and payable and  
15 subject to collection and foreclosure under the provisions of ORS 311.702 to 311.735 as in ef-  
16 fect immediately before the effective date of this 2024 Act.**

17 **SECTION 14. ORS 307.555 is amended to read:**

18 307.555. (1) As used in this section and ORS 307.558:

19 (a) “Affordable housing covenant” and “eligible covenant holder” have the meanings given those  
20 terms under ORS 456.270.

21 (b) “Condominium unit” or “unit” has the meaning given that term under ORS 100.005.

22 (c) [*Permanent*] “**Long-term**” means for a period of not less than 99 years.

23 (2) Upon compliance with ORS 307.162, land owned by an eligible covenant holder that is bur-  
24 dened by an affordable housing covenant requiring [*permanent*] **long-term** affordability is exempt  
25 from ad valorem property taxation if, for any property tax year:

26 (a) The improvements on the land constitute owner-occupied housing;

27 (b) Owner-occupied housing is being constructed or rehabilitated on the land for a reasonable  
28 period;

29 (c) The land is being held for a reasonable period for the construction of owner-occupied hous-  
30 ing;

31 (d) The owner-occupied housing on the land is unoccupied while offered for sale as owner-  
32 occupied housing; or

33 (e) The owner is required to be absent from the owner-occupied housing on the land by reason  
34 of health or active military service.

35 (3)(a) Upon compliance with ORS 307.162, 27 percent of the assessed value of an owner-occupied  
36 condominium unit burdened by an affordable housing covenant requiring [*permanent*] **long-term**  
37 affordability is exempt from ad valorem property taxation.

38 (b) An owner-occupied condominium unit that otherwise remains eligible shall continue to re-  
39 ceive the partial property tax exemption granted under this subsection if, for any property tax year:

40 (A) The unit is being rehabilitated for a reasonable period and will constitute owner-occupied  
41 housing after the rehabilitation is complete;

42 (B) The unit is unoccupied while offered for sale as owner-occupied housing; or

43 (C) The owner is required to be absent from the unit by reason of health or active military  
44 service.

45 (4)(a) Except as provided in paragraph (b) of this subsection, for purposes of subsections (2)(b)

1 and (c) and (3)(b)(A) of this section, “reasonable period” means a period not exceeding seven years.

2 (b) If, before the end of the sixth consecutive property tax year for which land or an owner-  
3 occupied condominium unit is granted an exemption or partial exemption in the circumstances de-  
4 scribed in subsection (2)(b) or (c) or (3)(b)(A) of this section, the eligible covenant holder or owner  
5 believes that the construction, rehabilitation or holding period, as applicable, will continue past the  
6 end of the next following property tax year, the eligible covenant holder or owner may claim a  
7 three-year extension by filing a notice of extension with the county assessor.

8 (c) The extension becomes effective if the notice of extension is filed on or before April 1 pre-  
9 ceding the first property tax year for which the extension is claimed and is accompanied by a filing  
10 fee equal to the greater of \$200 or one-tenth of one percent of the real market value of the land or  
11 the owner-occupied condominium unit as of the most recent assessment date.

12 (5) Each year that a parcel of land or an owner-occupied condominium unit is granted exemption  
13 or partial exemption under this section, the county assessor shall enter on the assessment and tax  
14 roll that the property is exempt or partially exempt and is subject to potential additional taxes as  
15 provided under ORS 307.558 by adding the notation “potential additional taxes.”

16 (6) ORS 315.037 does not apply to this section.

17 **SECTION 15.** ORS 307.627 is amended to read:

18 307.627. (1) If, after application has been approved under ORS 307.600 to 307.637, a declaration  
19 defined in ORS 100.005 with respect to the property is presented to the county assessor or tax col-  
20 lector for approval under ORS 100.110, or if the county assessor discovers that the multiple-unit  
21 housing or a portion of the multiple-unit housing is changed to a use that is other than residential  
22 or housing, or if the exemption was granted for housing being or becoming subject to a low income  
23 housing assistance contract with an agency or subdivision of this state or the United States and the  
24 housing is not housing subject to a low income housing assistance contract as of a date the housing  
25 is required to be subject to a low income housing assistance contract in order to receive the ex-  
26 emption:

27 (a) The exemption granted the multiple-unit housing or portion under ORS 307.600 to 307.637  
28 shall terminate immediately, without right of notice or appeal;

29 (b) The property or portion shall be assessed and taxed as other property similarly situated is  
30 assessed and taxed; and

31 (c)(A) Notwithstanding ORS 311.235, there shall be added to the general property tax roll for the  
32 tax year next following the presentation or discovery, to be collected and distributed in the same  
33 manner as other real property tax, an amount equal to the difference between the amount of tax that  
34 would have been due on the property or portion had it not been exempt under ORS 307.600 to  
35 307.637 for each of the years, not to exceed the last 10 years, during which the property was exempt  
36 from taxation under ORS 307.600 to 307.637.

37 (B) In the case of multiple-unit housing described in ORS 307.603 (5)(a), this paragraph applies  
38 only if the low income housing assistance contract to which the housing was or was to become  
39 subject was not entered into, **was** breached or **was** terminated prematurely.

40 (2) If, at the time of presentation or discovery, the property is no longer exempt, additional taxes  
41 shall be imposed as provided in this section, but the number of years that would otherwise be used  
42 to compute the additional taxes shall be reduced one year for each year that has elapsed since the  
43 year the property was last granted exemption beginning with the oldest year for which additional  
44 taxes are due.

45 (3) The assessment and tax rolls shall show “potential additional tax liability” for each property

1 granted exemption under ORS 307.600 to 307.637.

2 (4) Additional taxes collected under this section shall be deemed to have been imposed in the  
3 year to which the additional taxes relate.

4 **SECTION 16. ORS 308.408, 308.411, 308.412 and 308.413 are added to and made a part of**  
5 **ORS 308.408 to 308.413.**

6 **SECTION 17.** ORS 311.990 is amended to read:

7 311.990. (1) Violation of ORS 311.270 is a Class B violation.

8 (2) Violation of ORS 311.350 is a Class B misdemeanor.

9 (3) Violation of ORS 311.425 (1) is a Class A violation.

10 (4) If a tax collector fails to comply with any of the provisions of law relating to the receiving  
11 and receipting of moneys and warrants collected by the tax collector for taxes, the tax collector  
12 commits a Class A violation. The court before whom the tax collector is tried shall declare the office  
13 of the tax collector vacant for the remainder of the **tax collector's** term *[of the tax collector]*.

14 (5) If a tax collector willfully returns as unpaid any tax *[which]* **that** has been paid to the tax  
15 collector, the tax collector commits a Class B misdemeanor.

16 (6) If a tax collector or sheriff neglects or refuses to pay over **to the county treasurer** all  
17 moneys collected **for taxes** by the tax collector or sheriff *[for taxes to the county treasurer]*, or

26 **SECTION 19.** ORS 307.651 is amended to read:

27 307.651. As used in ORS 307.651 to 307.687, unless the context requires otherwise:

28 (1) "Governing body" means the city legislative body having jurisdiction over the property for  
29 which an exemption may be applied for under ORS 307.651 to 307.687.

30 (2) **"Manufactured home" means a structure that complies with any or all of the follow-**  
31 **ing placement standards, or any less restrictive standard, for the approval of manufactured**  
32 **homes located outside mobile home parks:**

33 (a) **The structure shall be multisectional and enclose a space of not less than 1,000 square**  
34 **feet.**

35 (b) **The structure shall be placed on an excavated and back-filled foundation and enclosed**  
36 **at the perimeter such that the structure is located not more than 12 inches above grade.**

37 (c) **The structure shall have a pitched roof.**

38 (d) **The structure shall have exterior siding and roofing which in color, material and ap-**  
39 **pearance is similar to the exterior siding and roofing material commonly used on residential**  
40 **dwellings within the community or which is comparable to the predominant materials used**  
41 **on surrounding dwellings as determined by the local permit approval authority.**

1       **(f) The structure shall have a garage or carport constructed of like materials.**

2       [(2)] (3) “Qualified dwelling unit” means a dwelling unit that, at the time an application is filed  
3 pursuant to ORS 307.667, has a market value for the land and improvements of no more than 120  
4 percent, or a lesser percentage as adopted by the governing body by resolution, of the median sales  
5 price of dwelling units located within the city.

6       [(3)] (4) “Single-unit housing” means a structure having one or more dwelling units that:

7       (a) Is, or will be, upon purchase, rehabilitation or completion of construction, in conformance  
8 with all local plans and planning regulations, including special or district-wide plans developed and  
9 adopted pursuant to ORS chapters 195, 196, 197, 197A and 227.

10       (b) If newly constructed, is completed within two years after application for exemption is ap-  
11 proved under ORS 307.674.

12       (c) Is designed for each dwelling unit within the structure to be purchased by and lived in by  
13 one person or one family.

14       (d) Has one or more qualified dwelling units within the single-unit housing.

15       (e) Is not a floating home, as defined in ORS 830.700, or a manufactured structure, other than  
16 a manufactured home [*described in ORS 197.307 (8)(a) to (f) (2021 Edition)*].

17       [(4)] (5) “Structure” does not include the land or any site development made to the land, as  
18 those terms are defined in ORS 307.010.

19       **SECTION 20.** ORS 307.677 is amended to read:

20       307.677. Notwithstanding ORS 307.651 to 307.687:

21       (1) If the city finds that construction of single-unit housing was not completed in accordance  
22 with ORS 307.651 [(3)(b)] (4)(b), the city may extend the deadline for completion of construction for  
23 a period not to exceed an additional 24 consecutive months if the city further finds that:

24       (a) The failure to complete construction was due to circumstances beyond the control of the  
25 owner; and

26       (b) The owner had been acting and could reasonably be expected to act in good faith and with

35 (c) **Regardless of ownership, permanent improvements that would otherwise be**

37 **fees, charges and assessments related to property taxation if the permanent improvements:**

38 (A) **Are located on land that is:**

39 (i) **Owned by the United States and held in trust pursuant to federal law for a federally**  
40 **recognized Indian tribe in Oregon; and**

41 (ii) **Within Jefferson County or Wasco County;**

42 (B) **Consist of solar energy systems for the purpose of heating, cooling or generating**  
43 **electricity; and**

44 (C) **Are subject to a property tax program imposed by the tribe.**

45 (d) **Upon request, and pursuant to an intergovernmental agreement between the tribe**

1 **and the governing body of any county in which a portion of the permanent improvements is**  
2 **located, the county assessor shall provide such information as is necessary for the tribe to**  
3 **assess, impose and collect the tribal property taxes on the permanent improvements de-**  
4 **scribed in paragraph (c) of this subsection.**

5 **(e) Property granted exemption under paragraph (c) of this subsection is not centrally**  
6 **assessed for purposes of ORS 307.330.**

7 **(f) ORS 315.037 does not apply to the exemption granted under paragraph (c) of this**

25 rental housing are executed before July 1, 2017;

26 (B) For purposes of ORS 307.540 to 307.548, the requirements of ORS 307.543 have been satisfied;

27 (C) The property is offered for rent or is held for the purpose of developing low income rental  
28 housing;

29 (D) If occupied, the property is occupied solely by low income persons; and

30 (E) The property is located in a county in which more than 10 percent of the enrolled members  
31 of the eligible Indian tribe reside.

32 (4) As used in this section:

33 (a) "Eligible Indian tribe" means the Burns Paiute Tribe, the Confederated Tribes of Coos,  
34 Lower Umpqua and Siuslaw Indians, the Confederated Tribes of the Grand Ronde Community of  
35 Oregon, the Confederated Tribes of Siletz Indians of Oregon, the Confederated Tribes of the  
36 Umatilla Indian Reservation, the Confederated Tribes of Warm Springs Reservation of Oregon, the  
37 Coquille Indian Tribe, the Cow Creek Band of Umpqua Tribe of Indians or the Klamath Tribes.

38 (b) "Government services" means services provided by an eligible Indian tribe that:

39 (A) Are equivalent to services that a state or local government or the federal government cus-  
40 tomarily provides to its citizens;

41 (B) Are related to:

42 (i) Tribal administration;

43 (ii) Tribal facilities or tribal health facilities;

44 (iii) Elementary or secondary education or higher education, including community colleges;

45 (iv) Transportation;

1 (v) Fire or police;

2 (vi) Low income rental housing;

3 (vii) Utility services provided to an Indian reservation or to land held in trust by the United  
4 States for the benefit of an eligible Indian tribe; or

5 (viii) Cemeteries; and

6 (C) Other than government services related to the uses of property described in subsection (3)(c)  
7 of this section, do not generate income.

8 (c) "Low income":

9 (A) Means income at or below 60 percent of the area median income as determined by the  
10 Oregon Housing Stability Council based on information from the United States Department of  
11 Housing and Urban Development.

12 (B) For purposes of projects undertaken pursuant to the Native American Housing Assistance  
13 and Self-Determination Act of 1996 (P.L. 104-330), includes income that qualifies under 24 C.F.R.  
14 5.609.

15 (d) "Permanent improvements" means "real property" as defined in ORS 307.010 (1)(b)(B).

16 (e) "Utility services" means services related to sanitation, sewer, storm drainage and water.

17 **SECTION 26b. The exemption granted under ORS 307.181 (2)(c) applies to:**

18 **(1) The first solar energy system project completed on or after the effective date of this**  
19 **2024 Act.**

20 **(2) Property tax years beginning on or after July 1, 2025.**

22 **ADMINISTRATIVE CHANGES**

23  
24 **SECTION 27.** ORS 291.349 is amended to read:

25 291.349. (1) As soon as practicable after adjournment sine die of the odd-numbered year regular  
26 session of the Legislative Assembly, the Oregon Department of Administrative Services shall report  
27 to the Legislative Revenue Officer and the Legislative Fiscal Officer the estimate as of July 1 of the  
28 first year of the biennium of General Fund and State Lottery Fund revenues that will be received  
29 by the state during that biennium. The Oregon Department of Administrative Services shall base its  
30 estimate on the last forecast given to the Legislative Assembly before adjournment sine die of the  
31 odd-numbered year regular session on which the printed, adopted budget prepared in the Oregon  
32 Department of Administrative Services is based, adjusted only insofar as necessary to reflect  
33 changes in laws adopted at that session. The report shall contain the estimated revenues from cor-  
34 porate income and excise taxes separately from the estimated revenues from other General Fund  
35 sources. The Oregon Department of Administrative Services may revise the estimate if necessary  
36 following adjournment sine die of a special session or an even-numbered year regular session of the  
37 Legislative Assembly, but any revision does not affect the basis of the computation described in  
38 subsection (3) or (4) of this section.

39 (2) As soon as practicable after the end of the biennium, the Oregon Department of Adminis-  
40 trative Services shall report to the Legislative Revenue Officer and the Legislative Fiscal Officer,  
41 or the Legislative Assembly if it is in session, the amount of General Fund revenues collected as  
42 of the last June 30 of the preceding biennium. The report shall contain the collections from corpo-  
43 rate income and excise taxes separately from collections from other sources.

44 (3) If the revenues received from the corporate income and excise taxes during the biennium  
45 exceed the amounts estimated to be received from such taxes for the biennium, as estimated after

1 adjournment sine die of the odd-numbered year regular session, by two percent or more, the total  
2 amount of that excess shall be retained in the General Fund and used, in the manner described in  
3 ORS 291.345, to provide additional funding for public education, kindergarten through grade 12.

4 (4) If the revenues received from General Fund revenue sources, exclusive of those described in  
5 subsection (3) of this section, during the biennium exceed the amounts estimated to be received from  
6 such sources for the biennium, as estimated after adjournment sine die of the odd-numbered year  
7 regular session, by two percent or more, there shall be credited to personal income taxpayers an  
8 amount equal to the total amount of that excess, reduced by the cost certified by the Department  
9 of Revenue under ORS 291.351 as being allocable to credits described under this subsection. The  
10 excess amount to be credited shall be credited to personal income taxpayers in a percentage amount  
11 of prior year personal income tax liability as determined under subsection (5) of this section.

12 (5)(a) If there is an excess to be credited under subsection (4) of this section, on or before [*Oc-*  
13 *tober*] **November** 1, following the end of each biennium, the Oregon Department of Administrative  
14 Services shall determine and certify to the Department of Revenue the percentage amounts of credit  
15 for purposes of subsection (4) of this section. The percentage amounts determined shall be percent-  
16 age amounts to the nearest one-tenth of a percent that will distribute the excess to be credited to  
17 personal income taxpayers.

18 (b) The percentage amount applicable to subsection (4) of this section shall equal the amount  
19 distributed under subsection (4) of this section divided by the estimated total personal income tax  
20 liability for all personal income taxpayers for tax years beginning in the calendar year immediately

23 multiplying the percentage amount determined under paragraph (b) of this subsection by the total

26 amount to be credited to the taxpayer.

27 (d) The credit shall be determined based on the tax liability as shown on the return of the tax-  
28 payer or as corrected by the Department of Revenue.

29 (e) The credit shall be computed after the allowance of a credit provided under ORS 316.082,  
30 316.131 or 316.292, but before the allowance of any other credit or offset against tax liability allowed  
31 or allowable under any provision of law of this state, and before the application of estimated tax  
32 payments, withholding or other advance tax payments.

33 (f) For personal income taxpayers, if a credit applied against tax liability as described in para-  
34 graph (e) of this subsection reduces tax liability to zero and an amount of the credit remains unused,  
35 the remaining unused amount shall be refunded to the taxpayer. For purposes of ORS chapters 305,  
36 314, 315 and 316, refunds issued under this paragraph are refunds of an overpayment of tax imposed  
37 under ORS chapter 316.

38 (g) The Department of Revenue may prescribe by rule the manner of calculating and claiming  
39 a credit if the filing status of a taxpayer changes between the tax year for which a credit may be  
40 claimed and the succeeding tax year.

41 (6) A refund may not be made under this section to a taxpayer if the amount of the refund is  
42 less than \$1.

43 (7) Not later than [*October*] **November** 15 following the end of the biennium, the Department  
44 of Revenue shall provide information and guidance to taxpayers relating to the calculation of the  
45 credit. The department may make the information and guidance available electronically or other-



1 wise.

21 Service upon the department or the local government shall be accomplished by the clerk of the tax  
22 court filing the copy of the complaint with the Director of the Department of Revenue or the ad-  
23 ministrator of the tax imposed by the local government. Except as otherwise provided by law, other  
24 service shall be accomplished as provided in the rules of practice and procedure promulgated by the  
25 tax court.

26 (c)(A) The complaint shall be entitled in the name of the person filing the same as plaintiff and  
27 the department, county, taxpayer or other person or entity as defendant. If the complaint relates to  
28 value of property for ad valorem property tax purposes and the county has made the appraisal, the  
29 complaint shall be entitled in the name of the person filing the same as plaintiff and the county  
30 assessor as defendant.

31 (B) If any, a copy of the order of the department or board of property tax appeals shall be at-  
32 tached to the complaint.

33 (2) The complaint shall state the nature of the plaintiff's interest, the facts showing how the  
34 plaintiff is aggrieved and directly affected by the order, act, omission or determination and the  
35 grounds upon which the plaintiff contends the order, act, omission or determination should be re-  
36 versed or modified. A responsive pleading shall be required of the defendant.

37 (3) In any case in which the taxpayer is not the appealing party, a copy of the complaint shall  
38 be served upon the taxpayer by the appealing party by certified mail within the period for filing an  
39 appeal, and an affidavit showing such service shall be filed with the clerk of the tax court. A copy  
40 of the order of the department, if any, shall be attached to the complaint. The taxpayer shall have  
41 the right to appear and be heard.

42 (4)(a) At any time in the course of any appeal before the tax court, the department may inter-  
43 vene as a matter of right. A copy of any order or judgment issued by the tax court in any case in  
44 which the department is an intervenor shall be served upon the department in the manner provided  
45 in subsection (1)(b) of this section.



1 (b) The tax court, in its discretion, may permit other interested persons to intervene by filing  
2 a complaint in such manner and under such conditions as the court may deem appropriate.

3 **SECTION 40.** ORS 305.570 is amended to read:

4 305.570. (1)(a) Any person, including a county assessor, [or] county tax collector **or, for a tax**  
5 **described in ORS 305.410 (3), a local government's tax administrator**, aggrieved by and affected  
6 by a written decision of a tax court magistrate issued under ORS 305.501, or any person seeking a  
7 remedy in the tax court provided by statute, other than as provided in ORS 305.275 (1), may appeal  
8 to the regular division of the Oregon Tax Court, and appeal shall be perfected in the manner pro-  
9 vided in ORS 305.404 to 305.560.

10 (b) Except for an appeal brought by a county assessor, [or] county tax collector **or, for a tax**  
11 **described in ORS 305.410 (3), a local government's tax administrator**, the order being appealed  
12 under this subsection must affect the person or the property of the person making the appeal or  
13 property for which the person making the appeal holds an interest that obligates the person to pay  
14 taxes imposed on the property. As used in this paragraph, an interest that obligates the person to  
15 pay taxes includes a contract, lease or other intervening instrumentality.

16 (2) A taxpayer or political subdivision affected by a determination of the Department of Revenue  
17 authorized under ORS 305.620 may appeal to the tax court as provided in ORS 305.620.
