

## SENATE AMENDMENTS TO A-ENGROSSED SENATE BILL 1557

3 **“APPROPRIATIONS AND EXPENDITURE LIMITATIONS**

5 **“SECTION 12.** Notwithstanding any other provision of law, the General Fund appropri-  
6 ation made to the Oregon Health Authority by section 1 (1), chapter 591, Oregon Laws 2023,  
7 for the biennium ending June 30, 2025, for Health Systems Division - Administration, is in-  
8 creased by \$314,619, for carrying out sections 1 to 8 of this 2024 Act.

9 **“SECTION 13.** Notwithstanding any other law limiting expenditures, the limitation on  
10 expenditures established by section 5 (1), chapter 591, Oregon Laws 2023, for the biennium  
11 ending June 30, 2025, as the maximum limit for payment of expenses from federal funds,  
12 excluding federal funds described in section 2, chapter 591, Oregon Laws 2023, collected or  
13 received by the Oregon Health Authority, for Health Systems Division - Administration, is  
14 increased by \$314,619, for carrying out sections 1 to 8 of this 2024 Act.

15 **“SECTION 14.** Notwithstanding any other provision of law, the General Fund appropri-  
16 ation made to the Oregon Health Authority by section 1 (7), chapter 591, Oregon Laws 2023,  
17 for the biennium ending June 30, 2025, for state assessments and enterprise-wide costs, is  
18 increased by \$3,285, for carrying out sections 1 to 8 of this 2024 Act.

19 **“SECTION 15.** Notwithstanding any other law limiting expenditures, the limitation on  
20 expenditures established by section 5 (7), chapter 591, Oregon Laws 2023, for the biennium  
21 ending June 30, 2025, as the maximum limit for payment of expenses from federal funds,  
22 excluding federal funds described in section 2, chapter 591, Oregon Laws 2023, collected or  
23 received by the Oregon Health Authority, for state assessments and enterprise-wide costs,  
24 is increased by \$3,285, for carrying out sections 1 to 8 of this 2024 Act.

25 **“SECTION 16.** Notwithstanding any other provision of law, the General Fund appropri-  
26 ation made to the Department of Human Services by section 1 (7), chapter 610, Oregon Laws  
27 2023, for the biennium ending June 30, 2025, for intellectual/developmental disabilities pro-  
28 grams, is increased by \$187,528 for carrying out the provisions of sections 3 to 5 this 2024  
29 Act.

30 **“SECTION 17.** Notwithstanding any other law limiting expenditures, the limitation on  
31 expenditures established by section 3 (7), chapter 610, Oregon Laws 2023, for the biennium  
32 ending June 30, 2025, as the maximum limit for payment of expenses from federal funds, but  
33 excluding federal funds not described in section 2, chapter 610, Oregon Laws 2023, collected  
34 or received by the Department of Human Services, for intellectual/developmental disabilities  
35 programs, is increased by \$187,528 for carrying out the provisions of sections 3 to 5 this 2024
