**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure. The statement includes a measure digest written in compliance with applicable readability standards.

Digest: The Act requires DHS to set up a task force and come up with a plan for a program that allows people who receive SNAP aid to be able to use the aid to buy hot foods and hot foods that are ready to eat. The Act says who must be on the task force. The Act requires DHS to take steps to carry out the program. (Flesch Readability Score: 87).

Requires the Department of Human Services to convene a task force to analyze options available under federal law for a program that allows recipients of Supplemental Nutrition Assistance Program benefits to use the benefits for hot foods, including restaurant meals. Specifies the membership of the task force. Requires the department to implement the program on a statewide basis or as a pilot program.

Takes effect on the 91st day following adjournment sine die.

**A BILL FOR AN ACT**

2 Relating to Supplemental Nutrition Assistance Program benefits; and prescribing an effective date.

3 Whereas many of the hungriest Oregonians who rely on Supplemental Nutrition Assistance  
4 Program benefits face the most significant barriers to obtaining adequate nutrition from traditional  
5 groceries, including the lack of kitchen facilities or the means of preparing and cooking meals,  
6 special dietary needs or the need for specific foods due to prescription medications that they must  
7 take; now, therefore,

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1. (1) The Task Force on Maximizing Supplemental Nutrition Assistance Pro-**  
10 **gram Benefits is established.**

11 **(2) The task force consists of members appointed by the Director of Human Services who**  
12 **represent the geographic and racial or ethnic diversity of this state and who have:**

13 **(a) Expertise in food insecurity.**

14 **(b) Personal experience receiving Supplemental Nutrition Assistance Program benefits.**

15 **(c) Experience in the restaurant industry.**

16 **(d) Experience in the retail grocery industry.**

17 **(e) Personal or professional experience in working with Oregonians who experience bar-**  
18 **riers to accessing hot food, such as seniors, individuals with disabilities or homeless indi-**  
19 **viduals.**

20 **(3) The task force shall analyze options available under any applicable federal waivers or**  
21 **federal programs under 7 U.S.C. 2026, or other options available with federal approval, to**  
22 **maximize the food choices for recipients of Supplemental Nutrition Assistance Program**

20 (10) If there is a vacancy for any cause, the director shall make an appointment to be-  
21 come immediately effective.

22 (11) The task force shall meet at times and places specified by the call of the chairperson  
23 or of a majority of the members of the task force.

24 (12) The task force may adopt rules necessary for the operation of the task force.

25 (13) No later than January 31, 2025, the task force shall submit a report on the imple-  
26 mentation of the program, in the manner provided in ORS 192.245, to the interim committees

32 the task force in the performance of the duties of the task force and, to the extent permitted  
33 by laws relating to confidentiality, to furnish information and advice the members of the task  
34 force consider necessary to perform their duties.

35 (16) The department shall solicit public feedback on the plan developed under subsection  
36 (5) of this section to ensure that the department receives feedback from an equity perspec-  
37 tive before implementing the program.

38 (17) The department may implement the program on a statewide basis or initially as a

1       **To the extent permitted by federal law, the Department of Human Services shall allow**  
2 **recipients of Supplemental Nutrition Assistance Program benefits who lack access to kitchen**  
3 **facilities or a means of preparing meals to use the benefits to purchase hot foods and hot**  
4 **foods that are ready for immediate consumption, including restaurant meals.**

5       **SECTION 3. The amendments to section 1 of this 2024 Act by section 2 of this 2024 Act**  
6 **become operative one year after receipt of any approval that is necessary to carry out the**  
7 **plan for implementing the program described in section 1 of this 2024 Act or one year after**  
8 **the notification from the United States Secretary of Agriculture that no federal approval is**  
9 **necessary.**

10       **SECTION 4. The Department of Human Services shall notify the Legislative Counsel im-**  
11 **mediately upon receipt of:**

12       **(1) Any federal approval described in section 3 of this 2024 Act or the denial of approval;**  
13 **or**

14       **(2) Notification from the United States Secretary of Agriculture that no approval is**  
15 **necessary.**

16       **SECTION 5. Notwithstanding any other provision of law, the General Fund appropriation**  
17 **made to the Department of Human Services by section 1 (3), chapter 610, Oregon Laws 2023,**  
18 **for the biennium ending June 30, 2025, for self-sufficiency programs, is increased by \$481,371**  
19 **for carrying out section 1 of this 2024 Act.**

20       **SECTION 6. Notwithstanding any other law limiting expenditures, the limitation on**  
21 **expenditures established by section 3 (3), chapter 610, Oregon Laws 2023, for the biennium**  
22 **ending June 30, 2025, as the maximum limits for payment of expenses from federal funds, but**  
23 **excluding federal funds not described in section 2, chapter 610, Oregon Laws 2023, collected**  
24 **or received by the Department of Human Services, for self-sufficiency programs, is increased**  
25 **by \$698,970 for carrying out section 1 of this 2024 Act.**

26       **SECTION 7. This 2024 Act takes effect on the 91st day after the date on which the 2024**  
27 **regular session of the Eighty-second Legislative Assembly adjourns sine die.**

28
