**PROPOSED AMENDMENTS TO
SENATE BILL 1574**

1 On page 6 of the printed bill, after line 12, insert:

2 **“SECTION 4a. For the purpose of requesting a state or nationwide**
3 **criminal records check under ORS 181A.195, a humane investigation**
4 **agency, as defined in ORS 181A.340, may require the fingerprints of a**
5 **person who:**

6 **“(1) Is employed or applying for employment by the agency; or**

7 **“(2) Provides services or seeks to provide services to the agency as**
8 **a contractor, vendor or volunteer.”.**

9 On page 9, delete lines 22 through 28 and insert:

10 **“SECTION 9. Section 10 of this 2024 Act is added to and made a part**
11 **of the Oregon Vehicle Code.**

12 **“SECTION 10. A court shall, at the request of a party to a prose-**
13 **cution for driving while suspended or revoked in violation of ORS**
14 **811.175 or 811.182, admit into evidence data prepared or recorded by the**
15 **Department of Transportation that details the suspension of a person’s**
16 **driving privileges.**

17 **“SECTION 11. (1) The Oregon Public Defense Commission Lawyer**
18 **Trust Account is established as a trust account in the State Treasury,**
19 **separate and distinct from the General Fund. Interest earned by the**
20 **trust account shall be credited to the trust account. All moneys in the**
21 **trust account are appropriated continuously and shall be used by the**

1 **Oregon Public Defense Commission for the sole purpose of making**
2 **payments on behalf of clients of the commission.**

3 **“(2) The trust account established by this section consists of mon-**
4 **neys received by the commission on behalf of clients and temporarily**
5 **credited to the account prior to the distribution of the moneys on be-**
6 **half of clients.**

7 **“(3) Subaccounts may be established within the trust account when**
8 **the commission determines that subaccounts are necessary or desira-**
9 **ble.**

10 **“(4) Interest earned on moneys deposited in the trust account or in**
11 **any of its subaccounts shall be transferred according to rules of pro-**
12 **fessional conduct adopted pursuant to ORS 9.490 governing lawyer**
13 **trust accounts.**

14 **“(5) Moneys in the trust account are not subject to allotment under**
15 **ORS 291.234 to 291.260.**

16 **“SECTION 12. The amendments to ORS 192.672 by section 8 of this**
17 **2024 Act apply to hearings conducted before, on or after the effective**
18 **date of this 2024 Act.**

19 **“SECTION 13. The amendments to ORS 163A.005, 163A.115, 243.706,**
20 **243.808 and 243.809 by sections 1, 2 and 5 to 7 of this 2024 Act become**
21 **operative on January 1, 2025.**

22 **“SECTION 14. This 2024 Act being necessary for the immediate**
23 **preservation of the public peace, health and safety, an emergency is**
24 **declared to exist, and this 2024 Act takes effect on its passage.”.**
