RE: SB 1521 (-10), Expanding the Definition of a Child-Caring Agency (CCA)

Dear Chair Gelser Blouin, Vice Chair Robinson, and Members of the Committee:

Thank you for the opportunity to continue to engage over the weekend to develop the -10 amendment in coordination with ODHS. ODHS' top priority is ensuring the safety and stability of children. We have taken seriously concerns raised in recent months about the oversight of contracted providers supporting children experiencing or at risk of temporary lodging and have implemented changes to improve oversight and accountability. These steps include cancelling two of the contracts where serious concerns were raised, centralizing oversight of contracts that were previously managed by local districts and forming an afteraction review team to assess the ODHS contracting process and make recommendations to strengthen accountability of service providers.

Impact of -10 Amendment

The -10 amendment minimizes the impact to the provider community to the greatest extent possible while still achieving the intent of the bill to increase regulations on service providers contracted to provide placement safety and crisis stability to children in substitute care at risk of temporary lodging or children experiencing temporary lodging.

ODHS anticipates approximately 5-7 current service providers will be impacted by the -10 amendment's expansion of the definition of a Child-Caring Agency (CCA).

We have updated service providers that were informed of the anticipated impacts of the -6 and -8 amendments that they would no longer be impacted by the -10 amendment.

CCA Licensure

The providers listed above can become licensed CCAs today under the existing licensing type and Oregon Administrative Rules for a "Homeless, Runaway, and Transition Shelter," but will need several exemptions that ODHS will process quickly and effectively. As the Children's Care Licensing Program (CCLP) learns more about the services provided in this new statutory category, CCLP will decide on the most effective path forward with the two rulemaking options:

- Option 1 A new set of administrative rules will be drafted for this specific provider type.
- Option 2 Existing administrative rules will be amended to account for this unique type of service provider.

In the interim, CCLP and Child Welfare will collaborate to provide the necessary technical assistance to ensure the compliance of laws and regulations to ensure these service providers can confidently continue to serve the critical needs of children while they work on becoming a licensed CCA. Providers are encouraged to contact ODHS Children's Care Licensing <u>Program</u> with any questions or concerns about the CCA licensing application and process.

Evaluation and Report Back

ODHS welcomes the opportunity provide progress updates on the implementation of this bill and the CCA licensure of these providers.
