I am OPPOSED to the Hops stadium.

It is a "vanity project" for Mayor Steve Callaway. He wants an amphitheater, a plaza, and other "passive entertainment" facilities at the GFRC with NO TRAFFIC IMPACT ANALYSIS (TIA) as promised when they approved the Conditional Use 002-23 to add a rumored Hops stadium to the GFRC.

I was at the zoning board meeting then participants "cajoled and badgered the Citizens" on the hearing board into passing it. The "people on the board" admitted that they did "not do any economic comparison study" to determine what was lost, did NO TIA, said the one done 25 years ago in 1998 was valid. And promised to do a TIA study for ANY other modification to the Conditional 002-23 Use project.

He gave KL Wombacher (Hops manager and organizer of Short Season LLC, 27 rich investors) seed money when the team was in Yakima to come to Hillsboro in 2012 and is pushing the Hops on a town that does NOT WANT IT.

They have gone so far as to bus in elementary school age children to Hops games, practices, exhibitions, and various appearances to "Indoctrinate" children as fans using public funds.
