House Committee On Judiciary Capitol Building, Salem, Oregon Re: Testimony, SB 1576, "Relating to recreational immunity"

Chair Kropf, Vice-Chairs Andersen & Wallan, Committee Members:



The Oregon Coast Trail Action Plan bill became law in 2017, essentially by unanimous vote of legislators, and signed by the governor. <u>Thank you to those legislators in moving the process along towards realizing the vision of a completed Oregon Coast Trail</u>.

SB 1576, which I chose to call, the **"Let's Make Sure the Oregon Coast Trail Stays Open and Gets Done!"** bill, is potentially not only necessary to <u>keep open existing trail sections and public access to the beach</u>, but also most likely absolutely <u>crucial to complete the remaining gaps</u> to truly provide a quality recreational trail experience.

Why? <u>Without the kind of landowner liability protection strong recreational use statutes offer</u>, it most likely will not only be <u>hard to work with willing landowners</u> to negotiate public access for trail connections, but also <u>potentially impossible to fill in crucial gaps</u>. In short, without this important tool, <u>without strong recreational</u> <u>use statutes, you can probably forget about making a connected world-class Oregon Coast Trail a reality.</u>

SB 1576 is an opportunity to do just that, right here, right now, and just after the Oregon Coast Trail Action Plan was finalized last Fall 2023, too! And for members of this committee, <u>this is YOUR moment to keep things</u> <u>moving forward</u>.

Finally, therefore, **our organization strongly supports SB 1576**, and encourages everyone, for each and every legislator, to <u>keep moving the bill forward</u>, *"and for the love of trails,"* **make it <u>happen in the 2024 legislative session**.</u>
