- HB 3531 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the Commission on Indian Services to employ a natural resources management tribal liaison officer to facilitate opportunities for integrated natural resources management between Indian tribes and state agencies with natural resources management duties.
- HB 3786 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Appropriates moneys to the Oregon Ocean Science Trust for deposit in the Oregon Ocean Science Fund for the purpose of providing competitive grants.
- HB 3657 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Directs the State Department of Agriculture to establish a wildlife damage prevention and compensation pilot program.
- HB 2730 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes a beginning farmer and rancher incentive program in the State Department of Agriculture.
