HB 2950 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires the Land Conservation and Development Commission to update the statewide land use planning goal relating to "citizen involvement" by rule by June 30, 2027. HB 3103 \*\* \*\*Subsequent Referral(s) to Ways and Means

Directs the State Forester to establish sustainable harvest levels for harvesting timber on state forestland and develop a timber inventory model to inform sustainable harvest levels.

Makes changes related to a water supply grant program.

HB 3806

Authorizes the Water Resources Commission to approve a Deschutes River water bank pilot program.
