#### Public Hearing

- HB 2143  
Defines "five-needle protocol."
- HB 2457 \*\* \*\*Subsequent Referral(s) to Ways and Means  
Establishes the Rare Disease Advisory Council.
- HB 2204 \*\* \*\*Subsequent Referral(s) to Revenue  
Adds podiatric physicians and surgeons to the types of providers eligible for the tax credit allowed to rural medical care providers.
- HB 2549 \*\* \*\*Subsequent Referral(s) to Revenue  
Expands the rural health care income tax credit to include pharmacist services performed in rural communities.
- HB 2365 \*\* \*\*Subsequent Referral(s) to Revenue  
Adds mental health professionals, naturopathic physicians, pharmacists, medical laboratory scientists and medical laboratory technicians to the types of providers eligible for the tax credit allowed to rural medical care providers.
- HB 2390 \*\* \*\*Subsequent Referral(s) to Revenue  
Increases the amount of income tax credit allowed to rural medical providers.
- HB 2591 \*\* \*\*Subsequent Referral(s) to Revenue  
Establishes an income tax credit for physicians who practice anesthesiology and for certified registered nurse anesthetists who do not qualify for rural health care provider tax credits.
