Work Session

HB 3197 **

**Subsequent Referral(s) to Revenue

Requires the Legislative Revenue Officer to study the taxation of the sale of beer and wine.

Public Hearing

HB 2011

Prohibits health insurers and pharmacy benefit managers from restricting coverage of physicianadministered prescription drugs that are obtained by nonparticipating pharmacies.

HB 2564

Revises the insurance rate review process.

HB 2594

Requires a dental laboratory to register with the Health Licensing Office.

Work Session

HB 2748

Prohibits a nonhuman entity from using the title "nurse" or other similar titles.

HB 2789

Prohibits the Oregon Health Authority under specified circumstances from requiring, as a condition of reimbursing the cost of the service, a primary care provider to order a covered care management service provided by a licensed registered nurse to a medical assistance recipient.

HB 2948

Provides that only a registered nurse may supervise a nurse in a school setting with respect to the practice of nursing.

HB 3127

Requires medical certifiers and medical examiners to use the state electronic reporting system to report deaths to the Center for Health Statistics.

HB 2457 **

**Subsequent Referral(s) to Ways and Means

Establishes the Rare Disease Advisory Council.
