CARRIED OVER FROM THE 02/18/2025 MEETING: Enacts the interstate Dentist and Dental Hygienist Compact.

HB 3060

CARRIED OVER FROM THE 02/18/2025 MEETING: Enacts the PA Licensure Compact.

HB 2011

Prohibits health insurers and pharmacy benefit managers from restricting coverage of physician-administered prescription drugs that are obtained by nonparticipating pharmacies.

HB 2564

Revises the insurance rate review process.

HB 2594

Requires a dental laboratory to register with the Health Licensing Office.

#### **Work Session**

HB 2748

Prohibits a nonhuman entity from using the title "nurse" or other similar titles.

HB 2789

Prohibits the Oregon Health Authority under specified circumstances from requiring, as a condition of reimbursing the cost of the service, a primary care provider to order a covered care management service provided by a licensed registered nurse to a medical assistance recipient.

HB 2948

Provides that only a registered nurse may supervise a nurse in a school setting with respect to the practice of nursing.
