Public Hearing

HB 2685 ** **Subsequent Referral(s) to Ways and Means Directs the Oregon Health Authority to provide information on the screening protocol for cytomegalovirus to hospitals and birthing centers.

HB 2741 ** **Subsequent Referral(s) to Ways and Means Directs the Oregon Health Authority to maintain a state public health laboratory, administer a newborn bloodspot screening program and implement additional programs related to newborn bloodspot screening.

HB 3192 **

**Subsequent Referral(s) to Ways and Means Appropriates moneys from the General Fund to the Oregon Health Authority for the purpose of screening newborns for five specific diseases under the Northwest Regional Newborn Bloodspot Screening Program.

HB 3082

Requires prescription drug manufacturers to report to the Department of Consumer and Business Services the total number of consumers to which the manufacturer offered a patient assistance program who participated in the program, notwithstanding any increase in the price of the prescription drug for which the manufacturer offered the program.

HB 3086

Requires the Public Employees' Benefit Board to count payments made by or on behalf of an enrollee for the cost of certain prescription drugs when calculating the enrollee's contribution to an out-of-pocket maximum, deductible, copayment, coinsurance or other required cost-sharing for the drugs.

HB 3092

Requires the Oregon Educators' Benefit Board to count payments made by or on behalf of an enrollee for the cost of certain prescription drugs when calculating the enrollee's contribution to an out-of-pocket maximum, deductible, copayment, coinsurance or other required cost-sharing for the drugs.

HB 3211

Requires the Oregon Health Authority to develop and make available a nonopioid directive form. HB 2540

Requires certain health insurers to credit any amount an enrollee pays directly to a provider toward out-of-pocket costs and deductibles in certain circumstances.
