## Work Session

HB 2015 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires the Oregon Health Authority to study outdated language in the provisions of ORS chapters 414 and 430.

HB 2016

Requires the Oregon Board of Licensed Professional Counselors and Therapists to establish a schedule of violations and remove from the board's website and publicly accessible publications information related to a licensee's or associate's violations after a specified time.

- HB 2024 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires the Oregon Health Authority to study the behavioral health workforce.
- HB 2056 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires the Oregon Health Authority to study the cost of community mental health programs.
- HB 2059 \*\*

Directs the Oregon Health Authority to establish a unit dedicated to developing sufficient adult behavioral health facilities to serve the needs of each trauma system area in this state.

HB 2202

Requires the Oregon Health Authority to study redundancies in the provisions of ORS chapters 414 and 430.

### HB 2203

Requires the Oregon Health Authority to study the safety of behavioral health workers. HB 2205

Extends the term of a contract entered into between the Oregon Health Authority and a coordinated care organization to 10 years.

HB 2212 \*\*

\*\*Subsequent Referral(s) to Ways and Means Establishes the Task Force on the Prioritized List of Health Services.

HB 2221

Requires the Department of Consumer and Business Services to study health insurance.

#### HB 2387

Prohibits certain health professional regulatory boards from disciplining licensees for providing psilocybin services as licensed psilocybin service facilitators or for discussing psilocybin services with clients or patients.

HB 2573

Modifies the requirements for the Senior Emergency Medical Services Innovation Program.

HB 2794

Directs a health care facility to establish and maintain procedures that a staff member may use to submit to the health care facility a complaint regarding a medical supply or equipment that the staff member believes in good faith is faulty or dangerous.

HB 2917 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires the Oregon Health Authority to study potential changes to the prioritized list of health services compiled by the Health Evidence Review Commission under ORS 414.

HB 2940 \*\*

Establishes the Task Force on Hemoglobinopathies and Sickle Cell Disease.

HB 3134

Creates a process that exempts certain health care providers from prior authorization requirements under certain circumstances.

HB 3225

Specifies qualifications for a physician who is among the majority of the shareholders or directors of a professional corporation organized for the purpose of practicing medicine.

HB 3227

Voids noncompetition agreements, nondisclosure agreements nondisparagement agreements and nonsolicitation agreements between certain business entities and medical professionals, with specified exceptions, and prohibits the business entities from retaliating against the medical professional for violating the void agreements.

### HB 3380 \*\*

\*\*Subsequent Referral(s) to Revenue

\*\*Subsequent Referral(s) to Ways and Means

Increases the tax credit allowed to rural volunteer emergency medical services providers from \$250 per tax year to \$1,000 per tax year.

HB 3421

Requires certain policies and certificates of health insurance and medical assistance managed plans to cover biomarker testing with certain rules and requirements.

#### HB 3572 \*\*

\*\*Subsequent Referral(s) to Ways and Means Directs the Emergency Medical Services Program to develop a state emergency medical services 10-year strategic plan.

HB 3675

Requires the Oregon Health Authority to study staffing plans for hospitals.

HB 3760

Allows the Health Licensing Office to issue to a qualified applicant a license to practice art therapy as a provisional licensed art therapist.

HB 3761

Allows the Health Licensing Office to issue to a qualified applicant a license to practice art therapy as a provisional licensed art therapist.

HB 3799

Creates a method by which a health care practitioner may offer to treat a patient who has a terminal disease or severe chronic disease with an investigational product not approved by the United States Food and Drug Administration.

#### HB 3824

Authorizes a physical therapist to prescribe durable medical equipment.

#### HB 3902

Directs the Oregon State Board of Nursing to establish an advisory committee to study the nursing educator shortage and make recommendations to address the issues identified by the committee.

#### HB 3912

Requires an individual who uses the title "doctor" in connection with a health care profession to designate on specified material, including social media and professional name badges, the health care profession in which the individual earned a doctoral degree.

- HB 3916 \*\* \*\*Subsequent Referral(s) to Ways and Means Directs the Oregon Health Authority to award grants to certain recipients for certain workforce development activities.
- HB 3923

Requires the Oregon Health Authority to approve the transfer of 500 or more members of a coordinated care organization or dental care organization if the transfer meets specified conditions, unless the transfer diminishes patient care.
