#### Work Session

SB 549 A

Requires the Oregon Health Authority or a coordinated care organization to make a determination on a request for prior authorization for medical assistance coverage for the cost to repair complex rehabilitation technology within 72 hours after receiving the request.

SB 699 A

Expands the health insurance coverage of prosthetic and orthotic devices and exempts the Public Employees' Benefit Board and Oregon Educators Benefit Board from the expansion of covered services unless the boards provide notice to the Department of Consumer and Business Services.

SB 841 A

Authorizes the Oregon Health Authority to enter into an agreement with a federally recognized Indian tribe in Oregon or a tribal epidemiology center in Oregon to allow the tribe or center to accept reports of reportable diseases and investigate cases of reportable diseases.

SB 951 A

Prohibits a management services organization or a shareholder, director, officer or employee of a management services organization from owning or controlling shares in, serving as a director or officer of, being an employee of, working as an independent contractor with or otherwise managing, directing the management of or participating in managing a professional medical entity with which the management services organization has a contract for management services.

SB 957 A

Voids noncompetition agreements between a licensed health care provider and another person, with specified exceptions.

SB 1161 A

Directs the Oregon Health Authority to issue a license to an organ procurement organization to operate an organ transport vehicle.
