#### Public Hearing

HB 2127

Makes various changes to the laws that govern franchise agreements between motor vehicle dealers and manufacturers, distributors and importers.

HB 3178

Requires in a transaction for a motor vehicle that is contingent upon a lender purchasing the retail installment contract or lease agreement negotiated between the seller and a buyer that the lender purchase the retail installment contract or lease agreement within two days after the transaction concludes or, if the sale of the retail installment contract or lease agreement does not occur, that the seller either void the transaction or agree to finance the transaction.

HB 3177

Requires a motor vehicle seller to check a used motor vehicle's vehicle identification number against the National Highway Traffic Safety Administration's motor vehicle safety recall database and to repair or replace all parts of the motor vehicle that are subject to a safety recall before advertising or offering the motor vehicle for sale or lease.

HB 2709

Prohibits a warrantor from accepting a fee from a resident for an extended warranty unless the warrantor knows that the resident's motor vehicle qualifies for coverage under the extended warranty.

HB 3188 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Department of Consumer and Business Services to establish a program to guarantee against losses in mortgage loans that lenders extend to first-time home buyers.
