Work Session

HB 2130

Makes various changes to the responsibilities of the Oregon Insurance Guaranty Association with respect to providing coverage for the obligations of member insurers.

HB 2966 **

**Subsequent Referral(s) to Ways and Means

Establishes the State Public Finance Task Force.

HB 3020

Prohibits wagering on dog races.

HB 3023

Removes requirement that the Oregon Racing Commission transfer certain fees related to Multi-Jurisdictional Simulcasting and Interactive Wagering Totalizator Hubs to the General Fund.

HB 3371

Requires landlords to notify and treat lienholders of abandoned vehicles the same as lienholders of abandoned recreational vehicles, manufactured dwellings or floating homes.

HB 2330 **

**Subsequent Referral(s) to Ways and Means

Establishes the Task Force on Law Enforcement Interdiction Against Financial Scams on the Elderly.

HB 3447

Requires a business that makes retail sales of certain nitrous oxide canisters to verify the recipient is at least 18 years of age.
