Work Session

- HB 2966 ** **Subsequent Referral(s) to Ways and Means
Establishes the State Public Finance Task Force.
- HB 3115
Prohibits the transfer, for consideration, of winning Oregon State Lottery tickets or shares above a certain value.
- HB 3431
Expands the application of certain statutes requiring publication in a newspaper to allow publication in online news publications.
- HB 2563 ** **Subsequent Referral(s) to Ways and Means
Requires an insurer to provide to an insured a clear and reasonable explanation of the reasons for any increase in the premium amount for a qualified policy upon renewal of the qualified policy.

Public Hearing

- HB 3255 ** **Subsequent Referral(s) to Ways and Means
Prohibits an online business from operating in this state unless the online business maintains a permanent telephone number and electronic mail address that allows customers to contact the online business with concerns and receive a timely and substantive response.
- HB 3345 ** **Subsequent Referral(s) to Transportation
Requires taxis and rideshare vehicles to have rideshare plates that have cherry red lettering and numbering.
