## Public Hearing

HB 2071

Prohibits state and local governments from restricting certain activities related to blockchain protocols and digital assets.

### Work Session

SB 856 A

Authorizes officers and employees of the Oregon Racing Commission to place bets or wagers on certain race meets in the course of official auditing duties.

SB 102

Provides that a court may not stay or prohibit a Federal Home Loan Bank from exercising rights to collateral pledged by an insurer-member that is subject to a delinquency proceeding.
