HB 2980 ** **Subsequent Referral(s) to Ways and Means
Directs the State Department of Fish and Wildlife to establish a Wildlife Stewardship Program.

Public Hearing

HB 2656
Prohibits the Public Utility Commission, municipal electric utilities, electric cooperatives and people's utility districts from setting a maximum amount of cumulative generating capacity for solar net metering systems that is allowed to be interconnected.

HB 2062
Requires producers of batteries or battery-containing products to join a battery producer responsibility organization and implement a battery producer responsibility program for the collection and recycling of batteries.

HB 3018 ** **Subsequent Referral(s) to Ways and Means
Requires entities that cook, assemble, process, serve or sell food to recover and dispose of food waste as specified in the Act.

HB 2738
Prohibits the use of leaded fuel at race tracks in cities with a population of 500,000 or greater as of January 1, 2026.
