Work Session

HB 2817

Eliminates the closure of forestland, due to fire danger, by permit closure.

HB 3171

Changes the requirements for an energy resilience plan that a county develops under the Act.

HB 2567 **

**Subsequent Referral(s) to Ways and Means

Requires an eligible entity that receives a grant under the Heat Pump Deployment Program to agree to use best practices to maintain the security and confidentiality of personal information of individuals who apply for or receive financial assistance under the program from the eligible entity.

Public Hearing

HB 2375

Requires a person who is developing or repowering a wind energy facility to apply to the Federal Aviation Administration for installation of a light-mitigating technology system and, if approved, install the system within 24 months.

HB 3261 **

**Subsequent Referral(s) to Ways and Means

Establishes the Task Force on Renewable Diesel.

HB 2985

Modifies provisions relating to the administrative proceedings of the Public Utility Commission.
