Modifies the definitions of and grant requirements for Resilience Hubs and Resilience Networks.

HB 3091  
Requires the Department of Environmental Quality to establish clear administrative rules and internal directives with respect to permits or authorizations issued by the department.

HB 3087 \*\* \*\*Subsequent Referral(s) to Revenue  
Creates an income or corporate excise tax credit for the amount paid by an owner of an eligible generation facility for transmission services.

HB 2679  
Directs the State Department of Agriculture to classify certain pesticides containing neonicotinoids as restricted-use.
