#### Work Session

HB 2291

Requires the Oregon Business Development Department to study economic development in Oregon.

HB 2277

Requires the Oregon Business Development Department to study the semiconductor industry in Oregon.

HB 2322

Requires the Oregon Business Development Department to study economic development in Oregon.

HB 2417

Requires the Oregon Business Development Department to study signature research centers established by the Oregon Innovation Council.

HB 2418

Requires the Oregon Business Development Department to study the Small Business Innovation Research matching grant program administered by the Oregon Innovation Council.

HB 2415

Requires the Oregon Department of Administrative Services to study ports.

HB 2282

Requires the Oregon Liquor and Cannabis Commission to study alcohol.

HB 3837

Appropriates moneys to the Oregon Business Development Department to award grants to cities and Oregon Indian tribes with high poverty rates for the purpose of developing local poverty reduction plans.

HB 3614 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Oregon Business Development Department to develop and implement a program to reimburse companies that relocate headquarters to Oregon for tariffs paid on goods imported through the Oregon International Port of Coos Bay.

HB 3588

Requires the Secretary of State to study the effect of requiring physical street addresses for business registrations in light of changes to postal regulations.

HB 2121

Includes a liquor store agent appointed by the Oregon Liquor and Cannabis Commission in the definition of "licensee" for purposes of alcoholic beverages laws.

**Public Hearing**

HB 3541

Requires drive-through restaurants to provide a garbage can within 15 feet of a service window for customers to dispose of garbage from a motor vehicle after purchasing food or drink from the drive-through restaurant.
