#### Work Session

SB 870

(8:00-8:05 am) Exempts from public records disclosure the residential address and personal phone number of an individual who holds a specified permit issued by the Oregon Liquor and Cannabis Commission.

SB 871

(8:05-8:10 am) Requires Oregon Liquor and Cannabis Commission retail licensees to maintain invoices of alcoholic beverage deliveries.

#### Public Hearing

SB 557

(8:10-8:50 am) Requires at least one of the commissioners of the Oregon Liquor and Cannabis Commission to hold a marijuana processor, marijuana producer, marijuana retailer or marijuana wholesaler license.

SB 558 A

(8:50-9:30 am) Allows a marijuana licensee to provide samples of marijuana items to other marijuana licensees at temporary events registered with the Oregon Liquor and Cannabis Commission.
