HB 3835

Modifies provisions regarding the use of restraint and involuntary seclusion on certain young people.

HB 2593 \*\* \*\*Subsequent Referral(s) to Ways and Means Requires the Department of Early Learning and Care to study the impact on student parents and working parents of the waitlist to participate in the Employment Related Day Care subsidy program.

Modifies the number and description of members on the System of Care Advisory Council.

Modifies provisions of law regarding child support program administration.

2976 \*\* HB

\*\*Subsequent Referral(s) to Ways and Means Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to nonprofit groups for purposes related to interpretation of indigenous languages.

HB 2814

Authorizes the Department of Early Learning and Care to waive certain requirements for certified child care facilities upon good cause shown and if the resulting circumstances protect the welfare of the children and the consumer interests of the parents of the children.
