HB 3560

Expands areas where a child care facility may be sited.

HB 2452 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Directs the Department of Early Learning and Care to establish a program to award grants to child care resource and referral entities to help parents or guardians of children access child care.

HB 3775 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys from the General Fund to the Oregon Department of Administrative Services for distribution to the City of Salem for a plaza and memorial on the former site of the Fairview Training Center.

HB 3497 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Requires specified agencies to consider the effects of a proposed action on older adult populations.

HB 3802

Requires payment of state funds for early childhood special education and early intervention services be provided as monthly installments.

#### Public Hearing

HB 2061 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Establishes a task force on the recruitment and retention of case managers and adult protective services workers.

HB 2956

Requires the Department of Human Services to study adult foster homes.

HB 2924

Modifies the number and description of members on the System of Care Advisory Council.
