SB 875 A

Modifies the Oregon Foster Children's Bill of Rights and the Oregon Foster Children's Sibling Bill of Rights.

SB 729

Extends to all public bodies the prohibition against denying mental health services to individuals with intellectual or developmental disabilities.

SB 810

Directs the Department of Human Services to collaborate with the Department of Education to increase opportunities for individuals with intellectual or developmental disabilities to obtain and advance in competitive integrated employment.

SB 1099

Requires cities and counties to allow lands where worship is allowed to be used for preschool. 228 A

SB 228 A

Establishes the right of a resident of a residential care facility to organize and participate in resident groups, including an independent family council.

SB 741 A

Directs the Department of Human Services to report each even-numbered year to the relevant interim committees of the Legislative Assembly and the Joint Interim Committee on Ways and Means about compensation to individuals who maintain a foster home or to child caring agencies that authorize proctor foster homes.
