HB 2009 **

**Subsequent Referral(s) to Ways and Means

Requires the Department of Education to study the adequacy of public education in this state. HB 2517

Directs the State Board of Education to adopt by rule criteria by which a school district is required to participate in an intensive program for school districts with the highest needs or may choose to participate in the program.

HB 2508 **

**Subsequent Referral(s) to Ways and Means Directs the Department of Education to develop and implement a standardized method to be used by school districts, education service districts and the department to electronically create, collect, use, maintain, disclose, transfer and access student data.

HB 3435 **

**Subsequent Referral(s) to Ways and Means

Phases in the requirement that school districts offer lunch and breakfast to students at no charge, regardless of household income.

The following bill is scheduled solely for the purpose of moving it to the House Committee On Higher Education and Workforce Development

HB 3534 **

**Subsequent Referral(s) to Ways and Means

Provides for a waiver of tuition, fees and the cost of textbooks for veterans and the children of veterans from eligible post-secondary institutions.
